Indore Institute of Law organized an industry visit for the students of BBA Exclusive to Parle G at Sanwer Road. The visit was conducted on December 2, 2017, Saturday. A total of 24 students accompanied by faculty visited the industry and learned about the entire working along with the distribution and packaging process of the industry.

The visit began from Indore Institute of Law, Gendalal Bam Parisar, Rau. After reaching Parle G the students were escorted to the auditorium for screening of Parle G movie which showcased the start of the enterprise and development it went through in all these years. It also showed various products of the company in different categories like biscuit, confectionary etc. the plant had production capacity of 40 tons per day.

The students along with the faculty in-charge proceeded to the production area where the entire production process was observed by the students. The manufacturing area had various production areas. It started with the mixing area where dough was made using flour, sugar and other ingredients. It further passed through a belt where it was pressed into requisite size via machines and then it was passed through ovens with varying temperatures from 140 - 240 degrees. Once the biscuits were backed then it went for cooling through the belts. It had a bed of four such belts where the biscuit cooled before they are sent for packaging.

The packaging was done in automatic way where biscuits moved in a line via conveyers and packed automatically in a lot of six biscuits.

The last area had final packaging where all the packs were bundled together and put into a cardboard box. Students raised their queries with Mr. Ashish Tiwari who promptly resolved the same.
