## **GENERAL GUIDELINES**

1. Each college can send only 1 team of maximum 14 students.
2. Each individual can only participate in a maximum of 3 events. The Choices available are :
  - a. Choose any one event out of Moot Court Competition & Parliamentary Debate competition.
  - b. Choose any 2 events out of remaining 6 categories.

❖ **Note- If you have not selected any event from Moot Court or Parliamentary Debate then you can choose 3 events out of the remaining 6 events.**

3. The teams will get pick up facility by IIL on 24<sup>th</sup> November, 2017 morning.
  1. 09:00 A.M.
  2. 10:30 A.M.
  3. 12:30 Noon. **From Indore RailwayStation only.**

Alternately, the students can directly report to the reception counter, at Indore Institute of Law, Indore. For further clarification you can call the team ushers/coordinators allotted by the **Organizing Committee.**

4. It is mandatory for the Teams to report at the venue before 12:00 P.M. on 24<sup>th</sup> November, 2017.
5. Boarding and lodging will be provided to the participants from 24<sup>th</sup> November, 2017 to 27<sup>th</sup> November, 2017 Morning 10:00 A.M. only.

6. Host College will provide meals from 24<sup>th</sup> November, 2017 (lunch) to 27<sup>th</sup> November, 2017 Morning (Breakfast).
7. The language of communication in all the events shall be strictly restricted to English except street play.
8. All the participants should report at the venue to their respective competition coordinators half an hour before the starting of the competition. The team not reporting on time will be accountable for the disqualification of the team.
9. The participating teams are requested to send registration forms accompanied by DD latest by 8<sup>th</sup> November, 2017 positively. In case of any mishandling by the Postal / courier services IIL shall not be held responsible.
10. The Organizer reserves the right to change the venue/date any rule and/or frame any additional rule.
11. Students shall wear formal uniform (white shirt, black blazer, black tie, black trousers, white socks, black shoes/ballerinas) in all official occasions which include:
  - A. Inaugural and Valedictory Ceremony of the event.
  - B. All the Competitions.
12. Any type of nuisance created by participants in campus, competition & place of accommodation will lead to the disqualification of the team.
13. **College identity card is must for all students.**
14. All the participants must send their two latest passport size photograph along with Registration Form.
15. The competition venue for all events will be the IIL campus.
