INTERNATIONAL CLIENT COUNSELLING COMPETITION

ABOUTTHECOMPETITION

Indore Institute of Law is conducting a physical International Client Counseling Competition from 09/12/2022 to 11/12/2022 The Client Counseling Competition promotes greater knowledge and interest among law students in practical laws and counseling functions of law practice. It also encourages participants to develop interviewing, planning, and analytical skills in the lawyer-client relationship. The competition is open for only Law Students.

GUIDELINES AND ESSENTIAL INFORMATION

- The event will be conducted physically.
- It will be open only to law students.
- A total of 20 team can register in the competition.
- Participation will be First Come First Serve Basis.
- The teams will be provided with a Code.
- All the participants will get a Certificate of Participation and the Winners will get a Certificate of Merit.

RULES FOR CLIENT COUNSELLING:

TEAM COMPOSITION

The team should consist of 2 participants. Both the participants should be law students pursuing 5 Year or 3 Year Law courses and LL.M. Participants must wear formal attire.

COMPETITION FORMAT

There will be three rounds of Counseling Session

- Preliminary Round
- Semi-Finals
- Finals

Winners in each round with Top Scores will proceed to the next rounds.

CONSULTATION

This period should be used by the participant for inter alia consultation with the client during which participants are expected to derive the relevant information, outline the problem, find the client's expectation and propose solutions to resolve the problem.

POSTCONSULTATION

In the post-consultation period, the participants may talk to each other loudly to be audible to the judges. Participants should summarize the discussion/ interview, indicate the scope of legal work that can be undertaken and the legal issues that should be researched upon.

CRITIQUE

After the post-consultation round, the judges may question the participants on the matters discussed by the participants or the client during the consultation or post consultation period.

- Critique-5Minutes

Semi-Finals-40Minutes

- Consultation-25Minutes
- Post Consultation –8Minutes
- Critique–7Minutes

- Consultation-30Minutes
- Post Consultation –11 Minutes
- Critique-9Minutes
