MEMORIAL DRAFTING WORKSHOP: The workshop was conducted by Memo Pundits, an exclusive associated venture with Indore Institute of Law working specifically for training the students in the skills required for Moot Court Competitions and the 1st workshop for the same was conducted on the tricks and techniques for drafting a memorial for moot court competition.

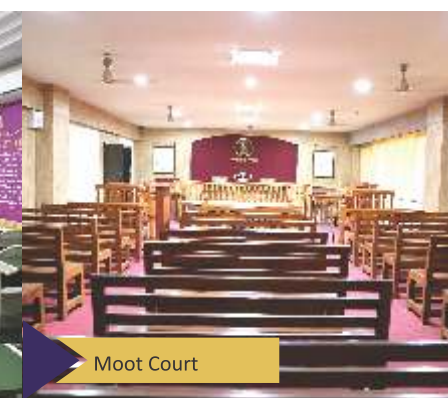

ADMISSION PROCEDURE

Candidates aspiring to join B.B.A LL.B. (Hons.) with Global and Transnational Studies offered by Indore Institute of Law have to take the mandatory IILET. IILET will be conducted in an offline mode across 15 cities of India.

SELECTION PROCEDURE

Selection is done in two phases:

1. Candidates will be short listed on the basis of the IILET score.
2. The short-listed candidates will be invited for Personal Interview (PI) and Psychometric Test (PT) at Indore Institute of Law.

Final Merit list shall be drawn on the basis of IILET Score (50%) and PI-PT performance (50%). In other words, it will be based on the cumulative marks scored on the scale of 100 marks wherein IILET score will be scaled down to 50 marks i.e. 50% weightage and the remaining 50% weightage will be assigned as follows: Personal Interaction (PI) - 30 marks i.e. 30% and Psychometric Test (PT) - 20 marks i.e. 20%.

ELIGIBILITY for Bachelor of Business Administration and Bachelor of Laws (B.B.A. LL.B.) with Global and Transnational Studies

The candidate should have passed 12th (10+2) standard examination from any government-recognized board with minimum 60% marks (55% for S.C. / S.T. students). Students who have appeared for their H.S.C finals and awaiting results are also eligible to apply, subject to submission of passing certificate by the notified date.
