1.3.1. Institution integrates cross cutting issues relevant to Gender, Environment and Sustainability, Human Values and Professional Ethics into the Curriculum

Indore Institute of Law is an **Affiliated Institute** of **Devi Ahilya University** and is abided by the syllabus provided by the university and is also bound to follow the academic session and exam schedules.

Indore Institute of Law has created its own unique process for delivering the Academic Curriculum for overall development of students not only academically but also by blending co-curricular activities. The Affiliating University follows stringent academic curriculum which at times is not in sync with the dynamic legal world and creates a gap between the academic and real world.

The institute runs law program and has four courses namely **LL. M., LL. B. (H), B.A.LL.B.(H), & B.B.A.LL.B(H)** The syllabus for the same is designed by Devi AhilyaVishwavidhyalay, which includes subjects like **Gender Justice, Environmental Law, Human Values, and Professional Ethics, Offenses against Child & Juvenile**. The institute imparts the knowledge about the subject by various ways discussed under-

1. Gender Justice

A. Curriculum

The topics covered in syllabus are about the condition of women in pre and post independent era and also about Women Empowerment. It also deals about feminist jurisprudence and various laws and provisions under it. The purpose of these laws is to enlighten students about the legal rights of women and their application in day to day life and society. It also tends to amend the historical injustices done towards the women and prevent it from occurring again. It also helps in providing a feminist perspective and deals the matters concerning women in a just and impartial or equitable manner.

It further throws light on the process of Inheritance which earlier was gender biased and hence prevented the females from having equal right on inheriting the ancestor properties in every religion. These laws enhanced

the understanding of students with respect to succession/inheritance law related to females. The laws also deal with issues related to marriage, divorce and succession related. It also covers social welfare laws for women which is a burning issue/. It is related to equal pay at workplace for equal work, additional domestic responsibility, and maternity benefits which are mostly ignored in job.

B. IQAC, Management & College Initiatives

The institute is devoted towards the enlightenment of its students regarding subject as sensitive and important as Gender Justice. The institute and its management is wholeheartedly devoted toward spreading awareness about the issue and is on the lookout for new ways to bring it among the public and local habitat.

SakshatAhilya Club

The institute initiated a student's club Named "**SakshatAhilya**" which is devoted towards spreading awareness about women and issues related to them and also provides solutions for the same. The club works in the nearby rural areas of Rau, Rangwasa&Sindoda.The club also visits Pithampur which is a Special Economic Zone and is having various industries and factories employing thousands of female workers.

The students often visit these areas to promote awareness about women's rights related to education, marriage, inheritance, domestic violence, dowry, female feticide rights related to equal pay for equal work, workplace safety rules, maternity benefits, sexual harassment related laws, etc. The industry is home to a huge women labor force that needs to be aware about their rights associated with employment.

Project Saheli

In pursuance of **Project Saheli**, IIL in collaboration with Bharat kiBeti , NGO distributed menstrual and sanitary pads and conducted street play on "Women Hygiene Awareness" with a view to promote menstrual hygiene among women. The institute in partnership with My FM has conducted "Betihai to Kalhai" street play on gender equality for which it received a letter of appreciation from Bharat Ki Beti NGO. Women empowerment camps and street play on "Women Empowerment" was organized by the institute in association with Jwala- Voice of Women, NGO. The institute along with AnantAman Welfare conducted nukkadnatak on " BetiBachaoBetiPadhao" and street play on "Equal Pay for Equal Work" in order to facilitate healthy working environment for all.

Sparsh Project

"**Sparsh Project**" a joint initiative of SashaktAhilya Club and LedX, which is based on **the concept of understanding "Good Touch-Bad Touch", is a unique initiative to protect children from sexual abuse and sexual exploitation.** For this purpose, IIL visits schools situated in Rau, Sindoda, Pitnampur on a regular basis and educate students about the signs to save themselves from sexual predators through

2. Professional Ethics:**Professional Ethics and Professional Accounting****Moot Court Exercise and Internship****Curriculum:**

The syllabus focuses on the professional development of a law student into a future lawyer. The affiliating university syllabus comprises of inculcating professional essentials needed by a lawyer in practicing the law. The course includes the code of conduct for a lawyer to be followed by him throughout his career a legal practitioner. From wearing a uniform in early days to greeting a judge in a court of law is taught in the syllabus as a part of ethics of legal profession.

The syllabus further throws light on Bar Council and State Bar Council and enrollment process. It also deals with moral and ethical issues faced by a lawyer and righteous way to handle such situations.

The course even highlights about the punishment for professional misconduct done by a lawyer during the course of employment and also the provisions of remedies available to a lawyer and also discusses about the grievance Redressal mechanism which needs to be followed to resolve the dispute.

The course also comprises of Bar and Bench relation and also about the provisions relating to Contempt of Court.

IQAC, Management & College Initiatives:**Uniform**

The college management has made it compulsory for all the students to wear black trousers and white shirt (Court Formals) twice a week to make students habituate to wear it during and after the completion of their legal education.

Besides the mandatory wearing of uniform management has also taken steps to nurture legal aspirants by equipping college library with relevant study material on Case Study comprising of professional misconduct, Art of Arguing, preparing and submitting well drafted documents related to the matter.

Court Visits and Other Visits

Court Visits are the mandatory activities for the law students as it is an integral part of internal assessment and Observational learning. The institute takes students to various International Courts and National Courts like International Court of Justice, International Criminal Court, Supreme Court, Parliament of India, M.P Legislative Assembly, High Court, District Court, Criminal Court, Labour Court, Revenue Court, Juvenile Justice Board, Consumer Forum, Central Jail, Panchayat etc. as a part of Observational and Evaluation Learning.

Various Competitions conducted by Indore Institute of Law

Moot Court Society – The Moot Court Society is the most important society as it is responsible for the conducting and organizing various moot court competitions which are a must for an aspiring lawyer. The society organizes and conducts various moot court competitions like Intra batch, Inter Batch, State level, and National and International level Moot Court Competitions via all these competition students learn Court Room manners & develop Professionalism and Ethics. It organizes the flag ship event **Smt. Nirmala Devi Bam Memorial International Moot Court Competition** which is an annual event and is patronized by Hon'ble Justice M. R, Shah, Judge, Supreme Court of India. It also organizes Fresher's Moot Court competition for the students of first semester to introduce them to the nuances of Mooting. The society also organizes guest lecturers related to moot court, drafting, pleading and Art of Advocacy. The society members are elected in a democratic manner via elections conducted by **Election commission**.

Internship

The institute has made it compulsory for every student to avail and go for internship where they learn the actual implication of law. Going to court makes the students understand the behavioral aspects and mannerism to be practiced in the court of law before the judge, prosecution and audiences in the court. **The mannerism of a lawyer defines the lawyer.**

Constitutional Law

The university syllabus majorly emphasis on the basic fundamental rights and duties of every citizen of the county and also discusses about the provisions related to the governance of the country. The syllabus throws light on three major organs of the states namely

- Legislature
- Executive
- Judiciary

The syllabus further discusses about the citizenship status of a citizen and formation of new states. The syllabus also enlightens the students about the remarkable judgements pronounced by the courts for the protection related to the protection of the constitution.

b. Human Rights:

The syllabus is dedicated to the Human Rights of a Citizen and Human Values. The entire syllabus is made up of all the laws and provision relating to protection, Preservation and Promotion of Basic Human Rights. The syllabus also discusses about various conventions and treaties on human rights and practices. The law further provides shelter to the disadvantaged groups like Women, Prisoners, Child, Dalit, Aid victims and minorities and also victims of medical mishaps or negligence.

IOAC, Management & College Initiatives:

- **Rubaroo – Samvidhaan se Samvad** – Cell keeping students abreast with the latest legal developments in various fields of law especially in **Constitutional Law** Recent landmark judgments relating to fundamental rights are discussed and understood in a better way so that all can get benefits. The cell organizes guest lectures by renowned judges related to fundamental rights and organizes lectures by experts in judicial services for preparation of judiciary examinations like Civil Judge, Assistant District Prosecution Officer and Public Prosecutor etc.
 - Procuring funds for celebrating events in lieu of various days like Constitution Day, Human Rights Day etc.

- Recruitment policy which is neutral with regard to religion and gender despite being a minority institution.
- Providing free ship and scholarship to needy students irrespective of caste, religion and gender.
- **Aashayein– Let the Hope Float** – The club work for the development of needy people who are deprived of even basic rights. As a part of **Social Responsibility** this club works for the betterment of vulnerable, Old Age People, Physically Challenged people, children living in orphanages, slums and shelters where they are able to sustain through a tough life. Often the club members collect donations, money collected in campus in lieu of uniform defaults, fines and penalties levied. This money is used to provide these under privileged people with basic necessities of life in the form of medicines, stationary, woolen cloths, food etc. The club raised an amount of Rs. 2,00,000/- approx from Students, Alumnie& Other peoples for Prof. Dipti Mishra for her treatment for a terminal disease in a span of 2 days and donated to her for her treatment. In covidtoo the club played an important role.
- During Covid – 19, the institute provided its premises to the administration for creating an isolation center. **As a frontline worker in pandemic times, IIL was the first to let its hostels and academic blocks as quarantine centres.** The institute’s buses were utilized for transportation of immigrant labourers from bypass to other major cities **continuously for 23 days** and thereby incurred an **expense of Rs. 63,000 per day.** For this generous initiative, **letters of Appreciation** was awarded **Mr. Shankar Lalwani, Member of Lok Sabha and by Mr. Manish Singh, Collector of Indore.**
 - Besides this the following initiatives were taken-
 - The management felicitated the corona warriors with a monetary appreciation and a memento and certificate of honor for their contribution in fight against corona.
 - It provided medical support (free scanning, distribution of medicines), free ration packets (raw and cooked food) to the needy.
 - Free Transportation facility was provided by the college by employing college buses to the returning migrant workers.
 - Free vaccination for the employees.
 - Provides internships and job opportunities at Indore Institute of Law for the local habitat to promote economic welfare and financial independence.
- Donated food, computers, building material for construction to International Dumb and Deaf School, Cloths, sports equipments, books and shoes at an orphanage and at an old age home. Donated audio study material to the vision impaired students.

To extend support, **Institutional Freeship** is provided in full fledge to the students who is in dire need. The HRD has a compliance policy, addressing the concern of Freeshipwhich includes parameters, process and procedure of availing Institutional Freeship. Over **2000+**students got benefited with the same aid in the past 5 years.

The syllabus further talks about the various Constitutional Provisions Related to Environment and various measures taken to protect it and prevent environmental pollution. The purpose of the syllabus is to make the budding lawyers aware the importance of environment and various laws and provisions under it to protect it. It further emphasizes on various actions taken or efforts taken by the government and world community to conserve and preserve it. The syllabus also focuses on hazardous impact of polluting environment.

B. IOAC, Management & College Initiatives:

- **Go Green Club** – The club works for the promotion and preservation of environment and inculcating these values in our students keeping in mind our motto of creating human legal professional and responsible citizen. The club organizes and participates in events like plantation, Swatch Bharat Abhiyanto promote awareness about the degrading environment and factors affecting environment and measures to protect it. The club promotes the use of bicycles for transportation of staff and students twice in a month. Club uses street play activities to make people aware about the harms due to degrading environment and future dangers posed by this. Go Green Club majorly monitors and properly collects all types of e-waste, solid, liquid and bio waste for proper disposal without affecting green and clean environment.
- As a commitment to its environment preservation, the institute established the Go Green Club with a view to conserve, protect and preserve the environment.
- The Go Green Club with a view to promote sustainable development practices and inculcate these values in our students has taken the following prominent measures:
- The club organizes and participates in events like plantation drives, street plays, workshop to promote awareness about the degrading environment and factors affecting environment and measures to protect it. For all its unique efforts to preserve environment, IIL has gained membership of Unique Eco Recycle.
- **Management also took following initiatives –**
 - Management promotes clean and pollution free environment and to promote this it encourages commutation via various ways like resource pooling to come and go from campus. Promoting bicycle usage and faculty coming on Saturday by bicycle is felicitated. At the end of the of the semester faculty coming maximum number of time in an academic session is given a letter of appreciation.
 - It uses solar energy and has a small bio gas plant which uses the leftover food and green waste which generates gas and it is used to cook in canteen.
 - The campus has LED bulbs which further reduces the electricity consumption and helps in reducing bills.
 - It uses various techniques related to water harvesting like rain water harvesting and also collects the collected water during rains via deep holes made in the grounds.

Animal Moot Court on was held on International Environment Day to represented the plight of animals. A total of 170 students participated representing various species of animals in the activity and was the largest of its kind breaking the world record held by Argentina in Golden Book of World Records.

SOLAR ENERGY

- Solar technologies convert sunlight into electrical energy either through photovoltaic (PV) panels or through mirrors that concentrate solar radiation. This energy can be used to generate electricity or be stored in batteries or thermal storage.
- The Jawaharlal Nehru National Solar Mission (JNNSM), also known as the National Solar Mission (NSM) was commenced in January 2010. It marked the first time the government focused on promoting and developing solar power in India. Under the scheme, the total installed capacity target was set as 20 GW by 2022.

BIO-GAS PLANT

- Biogas mainly comprises of hydro-carbon which is combustible and can produce heat and energy when burnt. Biogas is produced through a biochemical process in which certain types of bacteria convert the biological wastes into useful bio-gas. Since the useful gas originates from a biological process, it has been termed as bio-gas.
- Methane gas is the main constituent of biogas. Biogas helps in achieving Pollution Free Cities, Handling Organic Waste, Helpful for Women, Will Transform Energy Dependence, Addresses Handling of Livestock Manure, Reduces Carbon Dioxide Emissions, Will Improve Soil Quality, Reduce Gender Inequalities, Can be Helpful in Achieving SDG Goals.
- **Biogas Plant** can be installed in all the houses and they can drop the daily generating food waste into the biogas digester. The digester is designed in a way that bio- **Methanogenesis or Biomethanation** process will take place and food waste will be converted to methane and liquid manure. Liquid manure can be used as bio fertilizer by diluting it with equal quantity of water.
- Institute has Installed **Biogas Plant in the canteen of the Institute**. Through this the bio waste generated in the **Canteen's Kitchen**, waste food, and **Lawn waste** is used to produce Manure. This energy generated in the form of Biogas is then **used to cook food** in the kitchen.
- The **By-product** of biogas plant is **Liquid Manure** which is used in gardens situated in Institute's premises.
- Thus Institute's Canteen is **Self-sufficient** in terms of its energy requirement.
- **Indore Institute of Law (IIL)** as part of **GO GREEN CLUB INITIATIVE** has installed **biogas plant** in the college to energy through **alternative sources**.

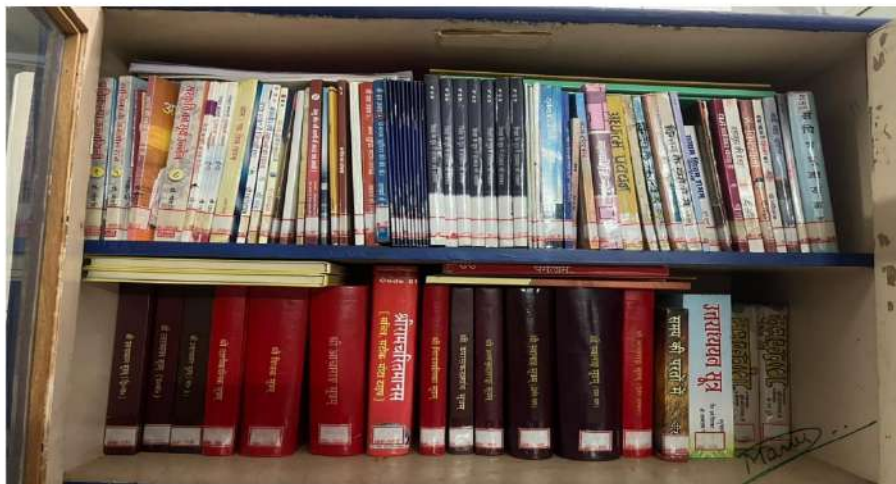

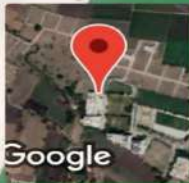
