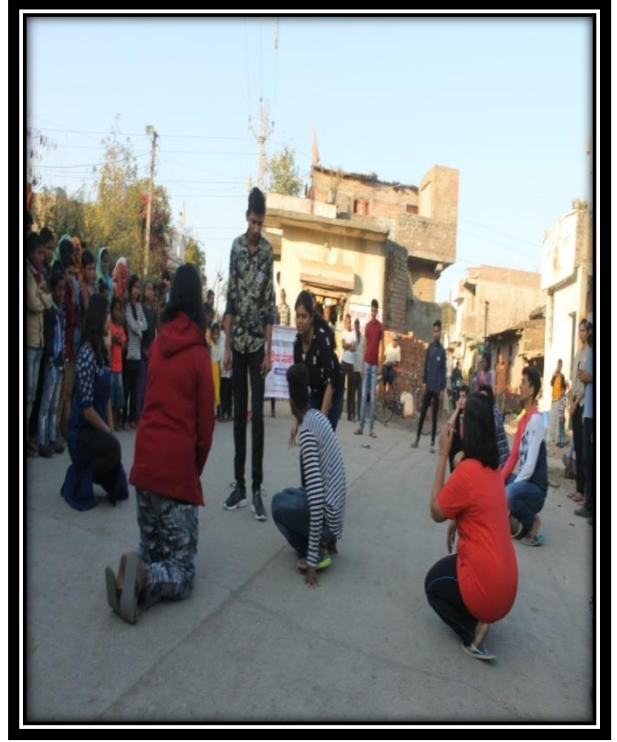
Street Play for Awareness Regarding Plastic Ban

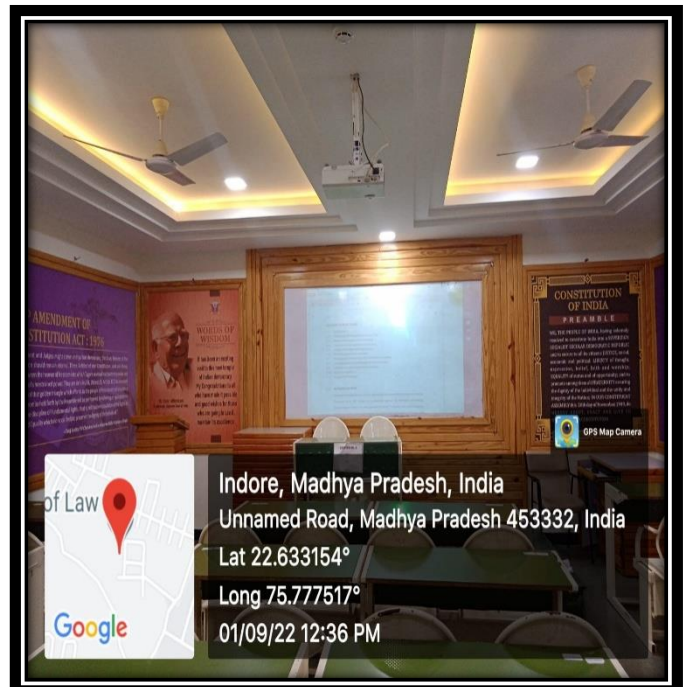

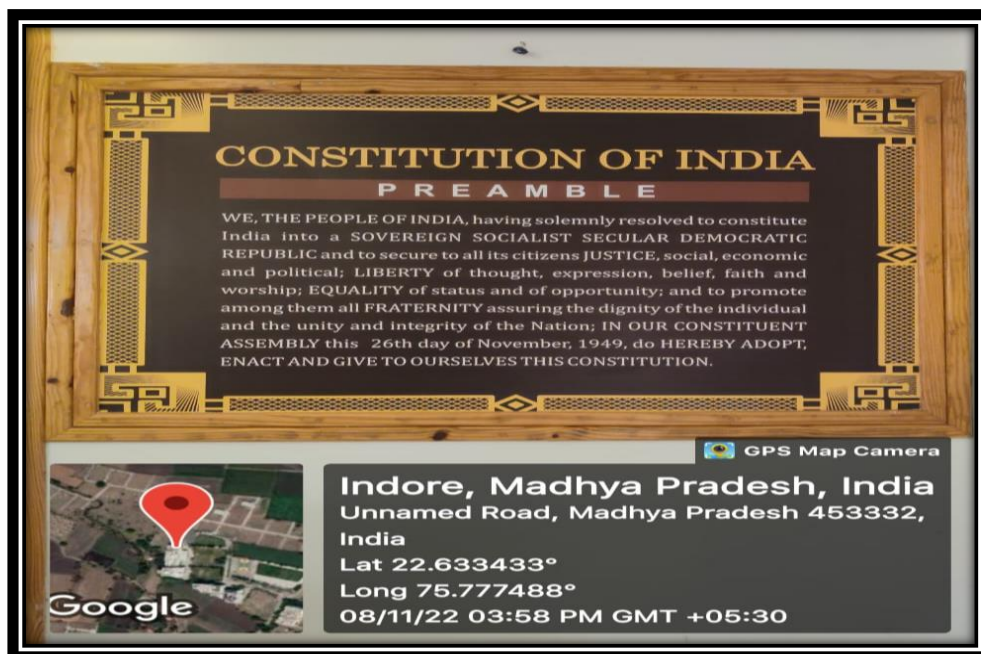
