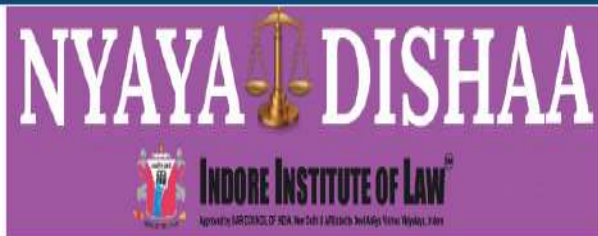

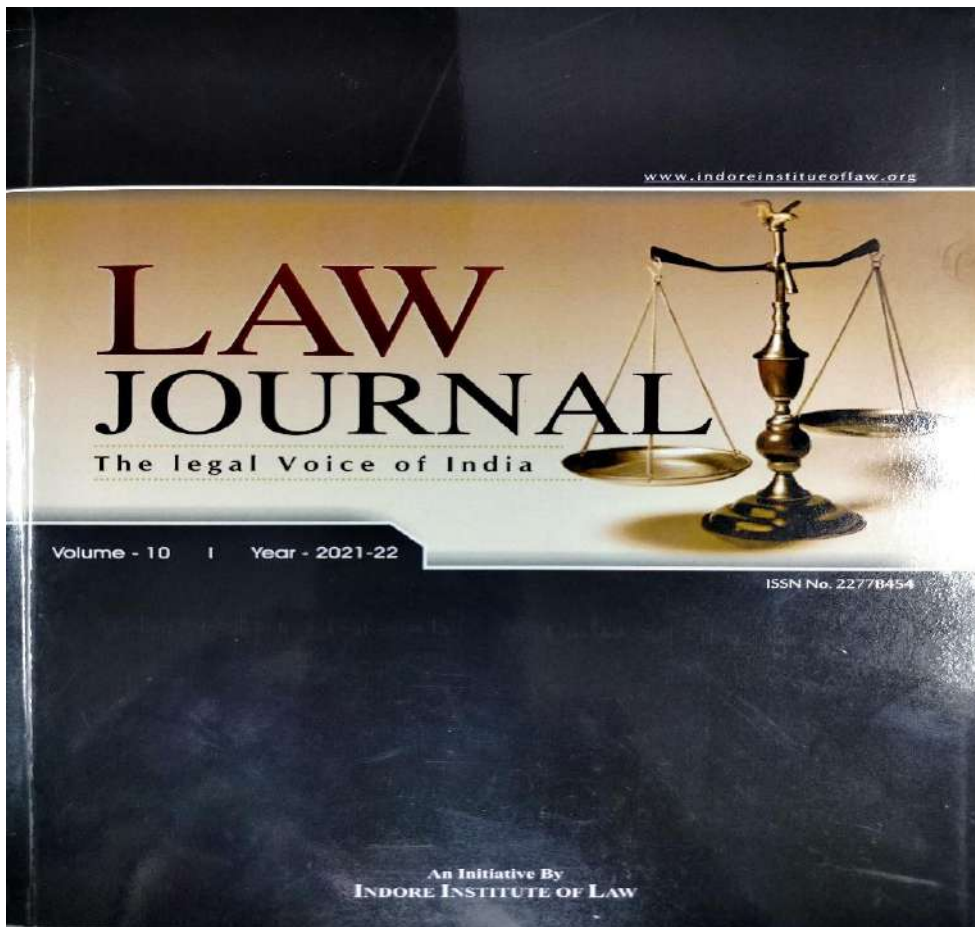



## A. Background

WHO estimates that mental, neurological and substance use disorders make up 10% of the global burden of disease. Around 1 in 5 of the world's children and adolescents have a mental disorder. Depression is one of the leading causes of disability, affecting 264 million people in the world. Moreover, almost 0.8 million people die by suicide every year in the world, and globally, suicide is the second leading cause of death among individuals aged 15-29 years.

Nearly 7.5% of the Indian population suffers from some form of mental disorder. India accounts for 15% of the global mental, neurological and substance abuse disorder burden. Moreover, persons with mental disorders are also known to be associated with a wide range of social and societal problems, if their illness is unrecognized or is inappropriately managed. An even more troubling fact is that there is an extreme shortage of mental health workers like psychologists, psychiatrists, and trained nurses in India. For example, there are only 3 psychiatrists per million people in India, while the corresponding figures for the USA and China are 105 and 22 psychiatrists, respectively. A huge majority of mental health professionals are located in urban areas. Hence, the shortage of trained mental health specialists in rural India is more severe.

The experience during the pandemic has also reinforced the need to focus on digital technologies, capacity building of frontline health professionals, as well as researchers and clinicians, and to focus on the health needs of marginalized populations. Resilient health systems which are focused on comprehensive health care provision along the life cycle should be a priority. Working across the life spectrum from perinatal mental health, to

child/school mental health, youth mental health, adult mental health, geriatric mental health, and highlighting attention towards public health priorities should be an area of focus.

Research, advocacy, development of policy recommendations, and supportive legal frameworks and advancements can play a crucial enabler role in enabling the country and states to better respond to priority health needs.



5. NLIU will establish a mechanism for resource sharing of the reading/training materials at library and online with IIL.
6. NLIU will engage with mental health experts and collaborators at IIL for designing courses or delivering lectures to the students on selected and specialized topics.
7. NLIU with IIL will explore the opportunities for collaborating with other stakeholders and individuals working in the domain of law, policy and mental health after mutual understanding.

#### **D. EXCHANGE OF HUMAN RESOURCES**

The Parties agree to explore ways of encouraging collaboration between researchers/faculty members from the two institutions. Specifically, the two institutions would identify appropriate researchers/faculty members as key collaborators, Principal Investigator(s)/ Co-Investigator(s) at their respective ends, and encourage members of their researchers/faculty to undertake short visits for lectures, facilitate research projects at either end, etc. The terms and conditions for each visit or an assignment, including those concerning stipend, travel, and housing, would be worked out between the partner institutions. The resource sharing of the reading/training materials at library can also be accessed mutually among the parties.

#### **E. AREAS OF COOPERATION**

The Parties agree to explore ways of encouraging collaboration between researchers/faculty members from the two institutions. Specifically, the two institutions would identify appropriate researchers/faculty members as key collaborators, Principal Investigator(s)/ Co-Investigator(s) at their respective ends, and encourage members of their researchers/faculty to undertake short visits for lectures, facilitate research projects at either end, etc. The terms and conditions for each visit or an assignment, including those concerning stipend, travel, and housing, would be worked out between the partner institutions. The resource sharing of the reading/training materials at library can also be accessed mutually among the parties.



## **B. SCOPE OF AGREEMENT**

This Memorandum of Understanding (MoU) provides for an overarching framework for collaboration for research and academic activities between both the parties that can be conducted during the period of the MoU.

The scope of activities shall include, but not be limited to, partnering for research and implementation projects focusing on the intersection of law, rights, marginalization and mental health; providing technical support to programs like developing courses on mental health law or related capacity building initiatives; facilitating internship programmes for students interested in mental health law and rights; queer and disability rights; criminal justice and psychology and organizing knowledge sessions like seminars, workshops, talks on mental health and law, as well as courses etc.

## **C. TERMS AND CONDITIONS OF COOPERATION**

For fulfilling the objectives of this agreement, following are the roles and responsibilities of each party:

1. Second Party will support and provide key technical support to First Party in law and mental health programs after mutual understanding. IIL will also seek technical support and guidance from key faculty, staff members and students from NLIU to refine its programs and projects focussing on law, rights, marginalization, policy and mental health.
2. IIL will establish a collaboration with nominated individuals from NLIU to partner in the research programmes and initiatives as Co-investigators and/or collaborators.
3. IIL will jointly identify and pursue opportunities with NLIU for formulation and submission of new research and implementation project proposals for possible funding by government and external agencies as per the mutual understanding.
4. IIL will establish a mechanism to engage the students of NLIU under apprenticeships/internships/research associates in various projects and activities arising from time to time as per the policies.



This MoU expresses a mutual desire by the NLIU, Bhopal and IIL, to cooperate in collaborative research, academics and implementation in law, rights, marginalization, policy and public health (especially mental health). Additional areas of cooperation may be added with the written consent of both the parties. Both parties shall act in good faith to ensure that the objectives in this Memorandum are realized.

#### **F. TERMS OF AGREEMENT**

1. Progress in realizing the terms and conditions referred to herein will be reviewed periodically as mutually agreed. The Memorandum may be amended at any time by mutual consent in writing by both parties.
2. Both parties reserve the right to terminate this Memorandum by tendering three months written notice to the other party.
3. The implementation and/or continuance of programmes or projects established pursuant to this Memorandum prior to the effective date of termination shall not be affected by the termination of this Memorandum.

#### **G. Financial**

There would be no financial commitment on either side as a part of this MOU. However, task specific financial arrangement as per internal policies of both the parties could be considered as per the mutual understanding.

#### **H. INTELLECTUAL PROPERTY AND CONFIDENTIALITY**

1. IIL and NLIU agree to respect each other's rights to Intellectual Property (IP). All background IP used in connection with this MoU shall remain the property of the Party that introduces it. No license is granted to any Party to use another Party's Background IP, unless specifically agreed to. Further, the IP rights that arise as a result of any collaborative research or joint activity under this MoU would be subject



## K. TERMINATION

1. This Memorandum shall come into force immediately upon the signature by parties.
2. The validity of this Memorandum is initially for five years from the date of its execution, and the same can be further extended by mutual agreement, if required.
3. This Memorandum can be terminated by either party by giving advance notice of three months without jeopardizing any work or collaboration between both the parties.

The objectives of the MOU will be implemented and regulated in the following manner:


### Student Exchange

This Memorandum of Understanding (MoU) is effective as of 01/03/2020 to establish an affiliation by and between Indore Institute of Law, Indore, India, affiliated with DAVV and recognized by Bar Council of India; hereinafter referred to as IIL.

and

Piedmont University, Winston-Salem, North Carolina, USA; accredited by the Transnational Association of Christian Colleges and School. Hereinafter, referred to as PU

#### **PREAMBLE**

WHEREAS, IIL and PU have many areas of common interest in Law & Management, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research. NOW THEREFORE, IIL and PU have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

#### **ARTICLE 1: OBJECT**

Both the Institution agree to develop and facilitate collaborative activities in the academic areas of mutual interest, on a reciprocation bases. The Institutions shall seek to promote –

1. The exchange of resource persons/faculties to the mutual benefit of the associating institutions
2. Collaborations in the field of teaching, research & development and consultancy in the field of mutual interest
3. The exchange of academic materials and publications,
4. Conducting lectures,
5. Undertaking joint research,
6. Attachment of staff for purposes of curriculum development and research skills,
7. Participating in-seminars, symposiums, and other types of academic activities,
8. Co-supervising post-graduate students,
9. Conducting study tours and joint consultancy work.

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including those concerning salary, travel funding, health insurance, and housing will be worked out between the institutes. A separate agreement will be entered into giving such details including term of exchange of any intellectual property.

#### **ARTICLE 2: COORDINATION**

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of IIL, and a programme coordinator from the side of PU, will periodically review and identify ways to strengthen cooperation between the two institutions.

#### **ARTICLE 3: CONFIDENTIAL INFORMATION**

Both the Institution does not absolve any confidential information during the research activity.

#### **ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS**

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both institutes to this Memorandum. Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same. Before any registration or commercialisation of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes, such consent not to be unreasonably withheld.

#### **ARTICLE 5: VALIDITY**

The Memorandum shall remain in force for a period of FIVE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

#### **ARTICLE 6: TERMINATION**

Either institution may terminate the MoU by giving written notice of six months in advance to the other institution.

#### **ARTICLE 7: AMENDMENTS/MODIFICATIONS**

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

#### **ARTICLE 8: ADHERENCE TO LAWS**

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

**ARTICLE 9: LEGAL EFFECT**



### **INTRODUCTON**

The judiciary is different from the executive and legislatives. Power and working is different from the legislative and the executive. Judiciary has a great power and plays an important role in USA. Power of judiciary is unalienable.

#### **Judicial Power:**

Constitution of USA provides some power to the judiciary, such as:

*Section 1:* The judicial Power of the United States, shall be vested in one Supreme Court, and in such inferior Courts as the Congress may from time to time ordain and establish. The Judges, both of the supreme and inferior Courts, shall hold their Offices during good behavior, and shall, at stated Times, receive for their Services, a Compensation, which shall not be diminished during their Continuance in Office.

#### **Characteristics and Attributes of Judicial Power**

The definition to the judicial power was given by so many justice, philosopher in their cases and in books respectively. Some of the very famous definition are as:

“Judicial power is the power of a court to decide and pronounce a judgment and carry it into effect between persons and parties who bring a case before it for decision.” Justice Samuel Miller, on the constitution<sup>1</sup>.

It is “the right to determine actual controversies arising between diverse litigants, duly instituted in courts of proper jurisdiction<sup>2</sup>.”

#### **Jurisdiction and Judicial power:**

The terms “judicial power” and “jurisdiction” are frequently used interchangeably:

*Jurisdiction:* The word jurisdiction is defined as the power to hear and determine the subject matter in controversy between parties to a suit<sup>3</sup> or as the “power to entertain the suit, consider the merits and render a binding decision thereon.”<sup>4</sup> The cases and commentary however, support, indeed require, a distinction between the two concepts.

Jurisdiction is the authority of a court to exercise judicial power in a specific case and is, of course, a prerequisite to the exercise of judicial power, which is the totality of powers a court exercises when it assumes jurisdiction and hears and decides a case<sup>5</sup>. Judicial power confers on federal courts the power to decide a case and to render a judgment that conclusively resolves a case. Included within the general judicial power are the ancillary powers of courts to punish for contempt of their authority<sup>6</sup>, to issue writs in aid of jurisdiction when authorized by statute<sup>7</sup>, to make rules governing their process in the absence of statutory authorizations or prohibitions<sup>8</sup>, to order their own process so as to prevent abuse, oppression, and injustice, and to protect their own jurisdiction and officers in the protection of property in custody of law<sup>9</sup>, to appoint masters in chancery, referees, auditors, and other investigators<sup>10</sup>, and to admit and disbar attorneys<sup>11</sup>

*Judicial power:* is the authority to render dispositive judgments, Congress violates the separation of powers when it purports to alter final judgments of Article III courts<sup>12</sup>. Once such instance arose

when the Court unexpectedly recognized a statute of limitations for certain securities actions that was shorter than what had been recognized in many jurisdictions, resulting in the dismissal of several suits, which then become final because they were not appealed. Congress subsequently enacted a statute that, though not changing the limitations period prospectively, retroactively extended the time for suits that had been dismissed and provided for the reopening of these final judgments.

In *Plaut v. Spendthrift Farm, Inc.*<sup>13</sup> the Court invalidated the statute, holding it impermissible for Congress to disturb a final judgment. “Having achieved finality, a judicial decision becomes the last word of the judicial department with regard to a particular case or controversy, and Congress may not declare by retroactive legislation that the law applicable to that very case was something other than what the courts said it was.”<sup>14</sup>

In *Miller v. French*<sup>15</sup>, by contrast, the Court ruled that the Prison Litigation Reform Act’s automatic stay of ongoing injunctions remedying violations of prisoners’ rights did not amount to an unconstitutional legislative revision of a final judgment. Rather, the automatic stay merely altered “the prospective effect” of injunctions, and it is well established that such prospective relief “remains subject to alteration due to changes in the underlying law.”<sup>16</sup>

Whereas all the judicial power of the United States is vested in the Supreme Court and the inferior federal courts created by Congress, neither has ever been vested with all the jurisdiction which could be granted and, Justice Story to the contrary<sup>17</sup>, the Constitution has not been read to require that Congress confer the entire jurisdiction it might. Thus, except for the original jurisdiction of the Supreme Court, which flows directly from the Constitution, two prerequisites to jurisdiction must be present: first, the Constitution must have given the courts the capacity to receive it, and, second, an act of Congress must have conferred it. The fact that federal courts are of limited jurisdiction means that litigants in them must

affirmatively establish that jurisdiction exists and may not confer nonexistent jurisdiction by consent or conduct.

### **The judicial breach.**

Article III of the Constitution, which establishes the Judicial Branch, leaves Congress significant discretion to determine the shape and structure of the federal judiciary. Even the number of Supreme Court Justices is left to Congress — at times there have been as few as six, while the current number (nine, with one Chief Justice and eight Associate Justices) has only been in place since 1869. The Constitution also grants Congress the power to establish courts inferior to the Supreme Court, and to that end Congress has established the United States district courts, which try most federal cases, and 13 United States courts of appeals, which review appealed district court cases.

Federal judges can only be removed through impeachment by the House of Representatives and conviction in the Senate. Judges and justices serve no fixed term — they serve until their death, retirement, or conviction by the Senate. By design, this insulates them from the temporary passions of the public, and allows them to apply the law with only justice in mind, and not electoral or political concerns.

Generally, Congress determines the jurisdiction of the federal courts. In some cases, however — such as in the example of a dispute between two or more U.S. states — the Constitution grants the Supreme Court original jurisdiction, an authority that cannot be stripped by Congress.

The courts only try actual cases and controversies — a party must show that it has been harmed in order to bring suit in court. This means that the courts do not issue advisory opinions on the constitutionality of laws or the legality of actions if the ruling would have no practical effect. Cases brought before the judiciary typically proceed from district court to appellate court and may even end at the Supreme Court, although the Supreme Court hears comparatively few cases each year.

Federal courts enjoy the sole power to interpret the law, determine the constitutionality of the law, and apply it to individual cases.

The courts, like Congress, can compel the production of evidence and testimony through the use of a subpoena. The inferior courts are constrained by the decisions of the Supreme Court — once the Supreme Court interprets a law, inferior courts must apply the Supreme Court's interpretation to the facts of a particular case.

### **The Supreme Court of the United States**

The Supreme Court of the United States is the highest court in the land and the only part of the federal judiciary specifically required by the Constitution.

The Constitution does not stipulate the number of Supreme Court Justices; the number is set instead by Congress. There have been as few as six, but since 1869 there have been nine Justices, including one Chief Justice. All Justices are nominated by the President, confirmed by the Senate, and hold their offices under life tenure. Since Justices do not have to run or campaign for re-election, they are thought to be insulated from political pressure when deciding cases. Justices may remain in office until they resign, pass away, or are impeached and convicted by Congress.

The Court's caseload is almost entirely appellate in nature, and the Court's decisions cannot be appealed to any authority, as it is the final judicial arbiter in the United States on matters of federal law. However, the Court may consider appeals from the highest state courts or from federal appellate courts. The Court also has original jurisdiction in cases involving ambassadors and other diplomats, and in cases between states.

Although the Supreme Court may hear an appeal on any question of law provided it has jurisdiction, it usually does not hold trials. Instead, the Court's task is to interpret the meaning of a law, to decide whether a law is relevant to a particular set of facts, or to rule on how a law should be applied. Lower courts are obligated to follow the precedent set by the Supreme Court when rendering decisions.

In almost all instances, the Supreme Court does not hear appeals as a matter of right; instead, parties must petition the Court for a writ of certiorari. It is the Court's custom and practice to "grant cert" if four of the nine Justices decide that they should hear the case. Of the approximately 7,500 requests for certiorari filed each year, the Court usually grants cert to fewer than 150. These are typically cases that the Court considers sufficiently important to require

their review; a common example is the occasion when two or more of the federal courts of appeals have ruled differently on the same question of federal law.

If the Court grants certiorari, Justices accept legal briefs from the parties to the case, as well as from amicus curiae, or "friends of the court." These can include industry trade groups, academics, or even the U.S. government itself. Before issuing a ruling, the Supreme Court usually hears oral arguments, where the various parties to the suit present their arguments and the Justices ask those questions. If the case involves the federal government, the Solicitor General of the United States presents arguments on behalf of the United States. The Justices then hold private conferences, make their decision, and (often after a period of several months) issue the Court's opinion, along with any dissenting arguments that may have been written.

### **The judicial power**

*Article III of the Constitution of the United States:*

Guarantees that every person accused of wrongdoing has the right to a fair trial before a competent judge and a jury of one's peers.

The Fourth, Fifth, and Sixth Amendments to the Constitution provide additional protections for those accused of a crime. These include:

- A guarantee that no person shall be deprived of life, liberty, or property without the due process of law.
- Protection against being tried for the same crime twice (double jeopardy).
- The right to a speedy trial by an impartial jury.
- The right to cross-examine witnesses, and to call witnesses to support their case.
- The right to legal representation.
- The right to avoid self-incrimination.
- Protection from excessive bail, excessive fines, and cruel and unusual punishments.

Criminal proceedings can be conducted under either state or federal law, depending on the nature and extent of the crime. A criminal legal procedure typically begins with an arrest by a law enforcement officer. If a grand jury chooses to deliver an indictment, the accused will appear before a judge and be formally charged with a crime, at which time he or she may enter a plea.

The defendant is given time to review all the evidence in the case and to build a legal argument. Then, the case is brought to trial and decided by a jury. If the defendant is determined to be not guilty of the crime, the charges are dismissed. Otherwise, the judge determines the sentence, which can include prison time, a fine, or even execution.

Civil cases are similar to criminal ones, but instead of arbitrating between the state and a person or organization, they deal with disputes between individuals or organizations. If a party believes that it has been wronged, it can file suit in civil court to attempt to have that wrong remedied through an order to cease and desist, alter behavior, or award monetary damages. After the suit is filed and evidence is gathered and presented by both sides, a trial proceeds as in a criminal case. If the parties involved waive their right to a jury trial, the case can be decided by a judge; otherwise, the case is decided and damages awarded by a jury.

After a criminal or civil case is tried, it may be appealed to a higher court — a federal court of appeals or state appellate court. A litigant who files an appeal, known as an “appellant,” must show that the trial court or administrative agency made a legal error that affected the outcome of the case. An appellate court makes its decision based on the record of the case established by the trial court or agency — it does not receive additional evidence or hear witnesses. It may also review the factual findings of the trial court or agency, but typically may only overturn a trial outcome on factual grounds if the findings were “clearly erroneous.” If a defendant is found not guilty in a criminal proceeding, he or she cannot be retried on the same set of facts.

Federal appeals are decided by panels of three judges. The appellant presents legal arguments to the panel, in a written document called a “brief”. In the brief, the appellant tries to persuade the judges that the trial court made an error, and that the lower decision should be reversed. On the other hand, the party defending against the appeal, known as the “appellee” or “respondent,” tries in its brief to show why the trial court decision was correct, or why any errors made by the trial court are not significant enough to affect the outcome of the case.

The court of appeals usually has the final word in the case, unless it sends the case back to the trial court for additional proceedings. In some cases the decision may be reviewed en banc — that is, by a larger group of judges of the court of appeals for the circuit.

A litigant who loses in a federal court of appeals, or in the highest court of a state, may file a petition for a "writ of certiorari," which is a document asking the Supreme Court to review the case. The Supreme Court, however, is not obligated to grant review. The Court typically will agree to hear a case only when it involves a new and important legal principle, or when two or more federal appellate courts have interpreted a law differently. (There are also special circumstances in which the Supreme Court is required by law to hear an appeal.) When the Supreme Court hears a case, the parties are required to file written briefs and the Court may hear oral argument.

## CONCLUSION
