**CDC Working**

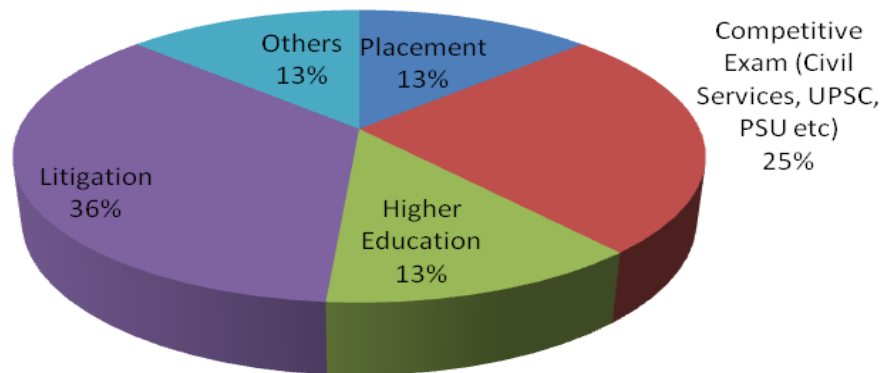

## Career Development Cell





