### **INTRODUCTION:**

The modern global economy can be described as a knowledge economy which is marked by technological innovations, the globally competitive need for innovation and the development of new products and processes to improve human life and solve problems (Baron & Shane, 2008). The transition from the post-industrial economy required that the rules and practices that determined success in the industrial economy were rewritten to meet the demands of a globalized and interconnected economy. In the current economic landscape, human capital is more likely to be valued for intellect, social skills, and reputation (DeNisi, Hitt & Jackson, 2003). The knowledge economy has impacted on research methodologies as well. Social science researchers need to critically consider the type of knowledge they are producing and the type of methods they are using to produce this knowledge. This ultimately determines their ability to remain relevant and compete for competitive funding (grant applications), book publishing. There is therefore a need that researchers critically look at the use of innovative research methodologies to generate social knowledge and to question the types of knowledge that results from any of their research activities. Qualitative research seems to be more suitable for innovative research methodologies because it aims to understand respondents' lived experience; examine the way respondents construct meaning in their lives by studying people in their natural context; describe diverse respondents' experiences and specifically amplify respondents' voices.

### **STATEMENT OF THE PROBLEM**

The qualitative researchers provide a great deal of descriptive detail based on their findings. They focus on asking 'why' questions and then provide explanations to answer these questions, which can provide richer data to enhance the knowledge generation process. Gubrium and Holstein (1997) cited in Bryman and Bell (2011) suggest four traditions of qualitative research, which have an important link to the type of knowledge qualitative research can produce.

Naturalism: Seeks to understand social reality ('as it really is') and provides rich descriptions of people and interactions in natural settings. This is the most commonly used tradition.

- Ethnomethodology/Participant Observation: Seeks to understand how social order is created through talk and interaction and a conversation analysis needs to be conducted.

- Emotionalism: Seeks to understand the inner reality ('inside' experience) of people. This tradition has not been used in a significant stream of research but yet, it can be included in innovative research methodologies.
- Postmodernism: Seeks to understand the different ways social reality can be constructed. The impact of culture for example can be included in innovative research methodologies. Qualitative researchers are influenced by interpretivism when they consider what should count as acceptable knowledge. For these researchers the differences between people and objects need to be respected, as well as the subjective meaning of social action (Bryman & Bell, 2011). This position is the result of the merging of Weber's notion of Verstehen, symbolic interactionism and phenomenology. Furthermore, qualitative researchers consider the viewpoints of the people.

### **LITERATURE REVIEW:**

Knowledge, Creativity, Innovation, and Qualitative Research This section explores the link between knowledge, creativity, innovation and qualitative research. The role of knowledge management in research will be highlighted, creativity will be explained and reasons to innovate will be given. The difference between innovation, adoption and adaptation will also be highlighted with specific reference to qualitative research. Knowledge Management in Social Sciences Research Knowledge refers to the theoretical or practical understanding of a subject, which can include factual information and descriptions, and/or skills acquired through education or experience. Knowledge can be implicit (practical skill or expertise).

Or explicit (theoretical understanding of a subject) (Sun, Mathews & Lane, n.d). Knowledge is the ultimate economic renewable as it is not depleted by use. The value of knowledge to an economy comes when this knowledge is shared and creates new sources of competitive advantage which can apply to all sectors. These sources are the effective use of knowledge, skills and innovative potential (Brinkley, 2006) which can be used in the service of mankind. Zhao (2003) compared the research process, specifically research supervision, to a knowledge management process as illustrated in Figure 1 below, which is important to explore briefly in this chapter.

Basically knowledge management consists of the preserving, embedding and enhancing of knowledge. Three stages can be identified in the knowledge management model for research supervision according to Zhao (2003), namely researchers develop new knowledge, theory and methodology (knowledge creation) through integrating, synthesizing and valuing existing knowledge (knowledge transfer), and then develop new insight into their area of investigation (knowledge embedding). Her knowledge management model is particularly significant in understanding knowledge in the knowledge economy from a research perspective.

### **RESEARCH QUESTIONS:**

In this study we specifically ask:

- 1) Can there be a methodology which will help in research properly?
- 2) What measures are taken by the researchers to develop new knowledge?

### INTRODUCTION:

### **LITERATURE REVIEW:**

Globally, induced abortion—safe or unsafe, legal or illegal—is a reproductive health service that is part of the lives of women, couples and communities in both developed and developing countries. When faced with unintended pregnancies, especially in contexts in which women lack access to effective family planning, induced abortion is an important part of women’s reproductive health care.

Ensuring the safety and availability of abortion services is critical to women’s health, and creating a supportive legal environment is one step in that process. In India, the second most populous country in the world, abortion has been legal on a broad range of grounds since 1971.

We focus on key issue areas on which a sufficient amount of literature exists: abortion laws, policies and guidelines; abortion services, including the availability and quality of services among different facility and provider types; task-shifting related to provision of abortion services; and the availability, effectiveness and safety of, and women’s preferences for, different abortion procedures (medical versus surgical).

### **RESEARCH QUESTIONS:**

In this study we specifically ask:

- 1) Can the Laws make the Changes in the Society for the Right to Abortion?
- 2) What measures have been taken by the Government to Implement the Laws to Safeguard women

### **PROPOSED RESEARCH METHODOLOGY:**

Due to all these causes and implications of female foeticide, many laws have been passed from time-to-time to control this menace.

India passed its first abortion-related law in 1971, the so-called Medical Termination of Pregnancy Act, which made abortion legit in almost all states of the country, but it was particularly made for the cases of medical risk to the mother and child conceived by rape. The law had also established physicians who could legally perform the abortion in the said scenarios. But the government had not considered the possibility of female foeticide based on technological advances. Due to this reason, this law proved to be highly ineffective.

During the 1980's, sex screening technologies in India was easily accessible to the common people. Due to this reason, a large number of reports started pouring in about the abuse of the sex screening technologies. Considering this problem, the Government passed the Pre-natal Diagnostic Techniques Act (PNDT) in 1994. This law was again amended due to various reasons, and it finally became Pre-Conception and Pre-natal Diagnostic Techniques (Regulation and Prevention of Misuse) (PCPNDT) Act in 2004. Its main goal was prevention and punishment of prenatal sex screening and female foeticide.

### **IMPLICATIONS:**

Many important changes were made in the PCPNDT Act, 2004. It brought ultrasound and amniocentesis under its ambit. It also led to the empowerment of the Central Supervisory Board and the formation of State Level Supervisory Board. The rules, regulations, and punishments are made more stringent.

Despite all these changes, it has been said that the implementation of this act has turned into a farce. It has been nearly two decades since the law came into force and despite this, not many changes have taken place in the society. Despite rulings given by the Supreme Court and various High Courts to make the existing law an impediment, the courts have shown their hesitancy in sending the offenders off to jail. The convicts in many cases have been let off only by a mere warning by the judge which has led to a mass negative reaction from the legal fraternity as well as social and academic activists. Lawyers and activists have unanimously demanded stringent punishment for the guilty while also fixing the accountability of the competent authorities handling the cases of sex detection.

### **DATA AND VARIABLES:**

The study will be based entirely on secondary data. The focus will be on safeguarding females and their right to abortion. The study will be conducted at almost all states level focusing on major Indian states. The states to be included are Andhra Pradesh, Assam, Bihar, Gujarat, Haryana, Karnataka, Kerala, Madhya Pradesh, Maharashtra, Orissa, Punjab, Rajasthan, Tamil Nadu, Uttar Pradesh, and West Bengal majorly.

### TITLE:Importance of Jain Teerth, Special Concern with SammedShikarji

#### INTRODUCTION:

After the contentious notice by the Jharkhand government to develop SammedShikarji sanctum as an ecotourism destination, a great deal of unusual uneasiness has broken out. For the Jain community, the hill tabernacle is a pivotal place of spiritual and religious deification. A no way -ahead- seen position of uproar from the Jain community was apparent after the notice, and it has only gotten worse since. The sacred place of SammedShikarji atop Parasnath hills in the ultramodern- day Giridih district of Jharkhand is where 20 of the 24 Tirthankaras, including Lord Parsvanatha, the 23rd Tirthankara, attained their spiritual redemption (moksha), according to Jain Holy Writ. The JMM- led administration of Jharkhand made this decision, and the Jains are vehemently opposed, claiming that it'll encourage alcohol and non-vegetarian food input by Tourists to their sacred position. Another complaint of discourteousness for the saintship of a far-off holy point in Gujarat surfaced at Shetrunjay hill in Palitana, where recent incidents of vandalization of a sanctum, unlawful encroachment, and trade of alcohol took place. This farther fueled the demonstrations. The central government has now stopped any similar conditioning in the bigger Parasnath Hills sanctuary in response to Jains' enterprises over the designation of their top sanctum SammedShikarji in Jharkhand as an ecotourism magnet. also, it has instructed the government to take harsh action against interdicted behaviors like drinking alcohol or" defiling of locales of religious and artistic value" or ecological detriment. Also, it has commanded the government to discipline roughly counter culturist gist like as drinking alcohol, as well as the" defiling of areas of religious and artistic worth" and ecological declination. Back in November, members of the Jain community alleged that the 'charanpaduka' (footprints) of Adinath placed at a temple on the Shatrunjay Hills were vandalized. A few days later, CCTV cameras were also found damaged at the site.

### STATEMENT OF THE PROBLEM

In 2019, Central Government's ministry of environment established various areas as Eco-Sensitive zone, on 28 December, 2021 Ministry of tourism under Jharkhand's state government launched a tourism policy which gives provisions to develop the sacred place of SammedShikarji as a tourist place.

1. The word 'Tourism' is a very controversial word in itself, because nothing can be derived about the nature of such places. It doesn't depict about the types of people that would be permitted to enter such places, types of activities that would be allowed, Whether the people who arrives would respect the Jain Dharma or not, what if they start bringing alcohol there? these are certain important questions and Jharkhand government has no answer to them.

The people of Jain community are demanding to declare the sacred place of SammedShikarji as a holy place of worship, so that its sanctity can be maintained. Follower of Jain community from all over the India were protesting peacefully for the same. So that Jharkhand Government can be notified with their demands and set their orders aside.

2. Another major problem was that the Government wasn't including and involving the stakeholders in their plans. Even after being aware of the fact that the place is having a religious history of many centuries, then also stakeholders weren't involved in the decision-making process of such a major decision.

### LITERATURE REVIEW:

- (A study of Jain sacred place): SammedShikarji , religious significance to its physical form – Maitry Shah: Bihar is a Remote and rural state and also it's the place for birth of Jainism , indeed it's very name derived from the Sanskrit word "vihara" Cleave out of the neighbouring Bihar in year 2000 to meet the autonomy demands of Adivasi (Trible) population, Jharkhand is land of immense natural and anthropological wealth. Many of the Jain munis used to travel to this place for meditation and achieved salvation. Jharkhand is Commonly known for its Jain pilgrimage place called SammedShikarji. It is a sacred place for Jain. It is said to be one of the highest peak, compare to other pilgrimage places of Jain. (Jeffery D. Long. New York): I. B. Tauris, 2009

- (Balbhadra Jain 2002) :This religious book references of Sramana culture found in Vedas and other texts of Vedic culture indicates the existence of it at the time of compilation of Vedas. The archaeological material found in the excavation of Mohan-jo-daro supports this view.Jain culture is an integral part of Sramana culture and its Tirthankaras and Acaryas influenced a lot to Indian culture.

Practically there is no field of knowledge in Indian tradition where we do not feel its effect. The holy Jain Tirthas, Temples, Sculptures, Idols, Manuscripts are spread throughout the country and they are very valuable assets of our rich culture heritage. Jain temples and idols have there antic and sculptural values. Jain Acāryas contributed a lot in the field of Grammer, Ayurveda, Astrology, Astronomy, Mathematics, Literature etc. The proper assessment of there contributions increases the beauty of Indian culture.

(Balbhadra Jain 2002) Jain Temples :This book illustrates temples as small-scale models of a Samavasarana. In the Samavasarana there are twelve Sri pavilions with gandhakuti, the canopied place where a Tirthankaras sits or rests on a throne. There is a wheel of religion at the gate of the Samavasarana and just ahead of it is a Māna-stambha (freestanding pillar-standard crowned by Jina images. The plan of a temple follows the same pattern. In ancient period Mana-stambha was an essential part of a temple. The wheel of religion is sculpted at the moulded basement of a temple.

- Vijay k. Jain (2015)This book illustrates the all 24 tirthankaras who attained nirvama : All the Jain temples are dedicated to one or another of 24 Tirthankara. among them Rishbhdev, Shantinath, Neminath, Parashnath, Mahavira are the most popular, as many number of temples are dedicated to them. The pictures of all the Tirthankara are indistinguishable, in this way the icon is perceived by the china (symbol) puts underneath the picture.
- (Dr.HukumchandBhavrilal 1991) SammedShikarjiJi : This book illustrates the uniqueness and strong belives of Jain for SammedShikarjiji. TirtharajSammedShikarjiis the place of meeting and unity of the entire Jain society,Because the Jain society, divided into many sects, easily merges here and their results are also pure at the time of the journey;Because of this, they get an easy opportunity to increase mutual harmony.
- (Dr.Brahmachandrashastri) Tirthankara : Tirthankara is a term of definition in Jainism. Whose sense is, the one who runs the religious pilgrimage or the promoter of religious pilgrimage, such a

There are 24 such pilgrims.

- (Kumar pal Desai 2008) This research analysis the teachings of Jainism ; The concepts of non-violence, truth, detachment, anekant and environment found in Jain religion can hold becon light to the world and similarly the values such as restraint, vegetarianism, forgiveness is the need of the hour.
- (Praveen k. Shah 2001)  
Jainism, religion of ecology and compassion:  
Founded and nurtured over the centuries in India, Jainism is a rich and profound way of life embraced by a strong and affluent minority. Though the religion has produced world class leaders and propagated philosophies for the human family, it is little known about outside the South Asian continent. The Jain community consisting of 8 to 10 million Jains or approximately 1% of the Indian population has produced successful men and women in all fields including, academics, government, medicine and the arts.
- (Heritage tourism : a need, with reference to Jain teerth,kundal Ar. Pranoti)  
The paper discusses about heritage tourism and discusses how the concept is applicable to KundalTeerth. This is the concept which is becoming popular. It also discusses about the place, its importance and significance, as well as present situation. Kundal, has a strong history from Chalukya period. There are tangible-intangible aspects associated with it. Caves, temples, inscriptions are found in digging showing the importance of a place. Lack of cooperation of governmental bodies and private sectors affected the development and conservation of KundalTeerth. It is seen that, trust is working and organizing various activities, things are going smoothly at a smaller scale but at a larger scale and larger circle more works, more activities, more advertisement should be done for which it requires more planning.

Dr. ShashankKela in 2018 examined the architectural and archaeological significance of Shikarji. The study notes that the site contains several ancient temples and sculptures that date back to the

- (Dr. Rajendra Jain 2016):

There have also been studies on the spiritual practices associated with Shikarji. A study by Dr. Rajendra Jain in 2016 examined the Jain concept of meditation and its role in the pilgrimage to Shikarji. The study found that meditation is an essential part of the pilgrimage experience and helps devotees connect with their spiritual selves.

- 6) Do you think conversion of religious places to tourist places for the purpose of revenue generation is justified?
- 7) Do you agree that promotion of tourism activity degrades the purity of religious sites?
- 8) Rate your satisfaction on scale of 5, how much will you be satisfied by converting a religious place to tourist place for enhancing GDP of the country?
- 9) Do you think such a kind of communal protests will result in reduction in introduction of revenue generation activities like conversion of religious places into tourist places and ultimately hampers the growth of the country?
- 10) Do you think conversion of SammedShikarji will contribute in employment generation for local inhabitants?
- 11) Can government restrict the sale of meat and alcohol at such tourist places with religious sentiment?

### **PROPOSED RESEARCH METHODOLOGY:**

The Questionnaire method used in this paper provides an insight into the Shikarji Controversy and the experiences of the Jain community. This technique gives a knowledge into human conduct and their encounters of cases dealing with controversy so far. This project's goal is to assess the SammedShikarji pilgrimage site's choice to become a tourism destination after the Jharkhand government made the announcement. This paper discusses the Shikarji dispute, which has sparked outrage across India and been a hot button issue. The Jains want the Shikarji Hill to be recognized by the relevant government officials as a "Place of Worship" through this effort because it is their most revered religious

Jains argued these initiatives represented attempts to commercialize the Shikarji hill and were opposed to the state government's plans to upgrade the infrastructure in the hill to increase tourism. Respondents' attitudes, experiences, and opinions are included in the list of questions or items used in this paper. The various questions regarding this controversy are of both a qualitative and quantitative nature, such as closed-ended and multiple-choice questions.

The secondary data has been collected from the sources like Books, Articles, Journals, and Internet, Orders issued by the Govt. of India as well as printed and digital news.

These findings should then be shared to educate and inspire other researchers to also explore their creativity and their ability to generate and apply innovative research methodologies.

### **SIGNIFICANCE OF SHIKARJI**

Both Digambara and Svetambara regard Shikarji as the most significant pilgrimage point, and both groups partake control of the top tabernacles. Because it's located on the Parasnath hill in the Giridih district of Jharkhand and is considered to be the largest passage point by both the Digambaras and the Svetambaras, SammedShikarji is so significant to the community that they don't want the position to become an eco-tourism destination. A "venerable peak" is the nonfictional meaning of the name "Shikarji.

Interestingly, "Parshvanatha," the 23rd Jain tirthankara who attained moksha then, is the source of the word "Parasnath." The Jain faith holds that Shikarji, along with Ashtapad, Girnar, the Dilwara temples on Mount Abu, and Shatrunjaya, are the "SvetambaraPanchaTirth," or the five most important places of passage. Palganj on the Giridih road, where there's a small sanctum to Parshvanatha, is the first stop on any passage to Shikarji. After that, they can offer offerings to the Madhuban temples at the bottom of Parasnath Hill.

During the circumambulation of Shikarji, pilgrims must journey roughly 27 kilometers. In 1768 announcement Jagat Seth rebuilt the tabernacles of Shikarji in their current configuration. still, the hero itself is old. The 1678 CE date is written in Sanskrit at the bottom of the image. One of the sanctuaries is aged than the 14th century. A number of Svetambara tabernacles were erected in the 20th century. Pilgrims serve fruits, flowers, rice, sandals, dhupa, sandals and diya then. At the bottom of Shikarji(Taleti) is a Bhomiyaji tabernacle. On the walls of the Jain tabernacle in Madhubanvill is a tempera of each tabernacle on Parasnath hill. The foremost tabernacle in which a BhaktamaraStotraYantra is elevated is the SvetambaraBhaktamara Temple innovated by Acharya Ramchandrasuri. At the bottom of the hill is a sizeable Digambar Jain tabernacle with a statue of NandishwarDweep. A Calcutta trafficker erected the Nichli Temple, which is notable for its armature. Arched entrances and tirthankara busts can be seen throughout the tabernacle

### **OBJECTIVES**

The objective of this project is to review the Shikarji decision after Jharkhand government declared to covert the pilgrimage site of SammedShikarji into a tourist destination out of the bolt. This paper is a discourse of the Shikarji controversy which has been a hot potato and the cause of protest all over India. We will further discuss the below objectives-

1. To find whether such a protest against an initiative by Government bolster the economic growth of the country, hampers the secular nature of the country or not?
2. To find whether it is economically beneficial to convert the pilgrimage site into a tourist site or not?
