**CDC Working**

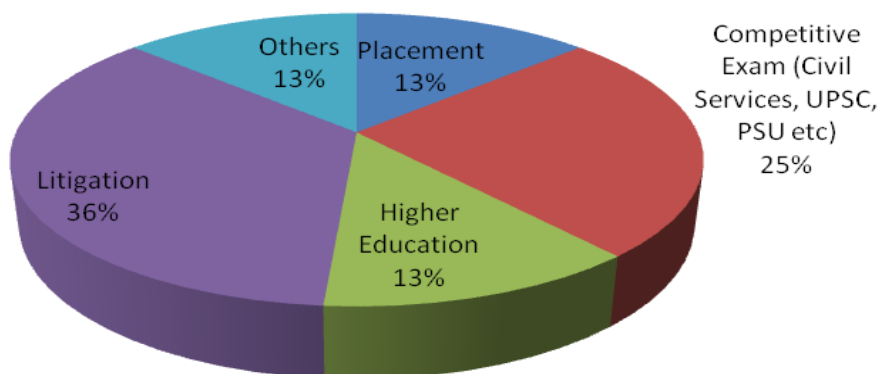

The Career Development Cell also hosts conferences, workshops, and competitions to help students


