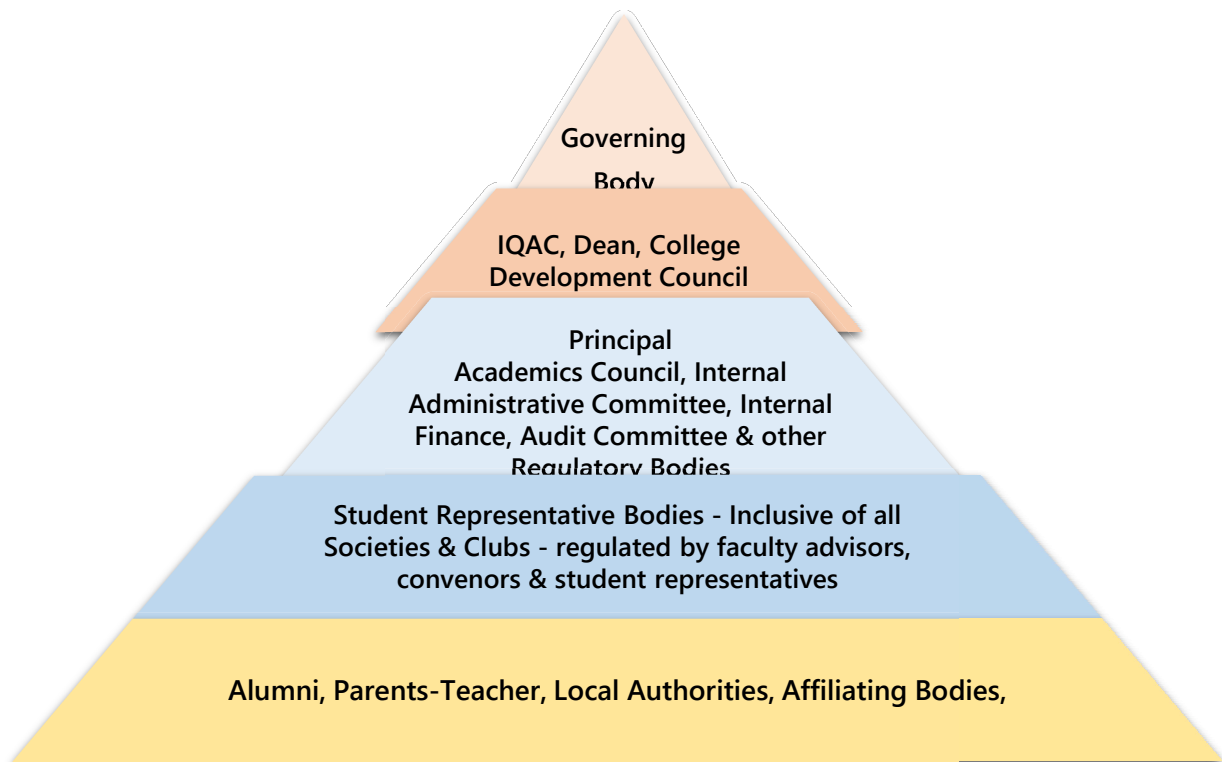

GOVERNANCE STRUCTURE OF THE INSTITUTE

It is in the basic principles of Administrative Law where we learn the importance of Decentralization in effective governance and the principles are applicable at every institutional entity. IIL follows the practice of decentralization in its true sense, in all the three pillars of the institution, viz. **Academics, Administration & Finance**.

All the major stakeholders of the Institute including Management, The Governing Body, Finance Department, The Dean, The Principal, Teaching and Non-Teaching Staff, Parents, Students, Alumni and Industry Experts, Affiliating Body and Local Authority work in a collaborative & democratic way of governance following the tacit rules of accountability in execution of their duties and responsibilities.

- **The Governance structure of the Institute is primarily constructed in two segments namely; Policy Building Bodies & Policy Implementation Bodies. The first two**

segments of pyramid represent the Policy Building Bodies while the remaining three represents the Policy Implementation Bodies.

- The highest body in the Institution's governing structure is the Governing Body comprising of Members of Icon Education Society, Management, as well representation of each stake holding entity in the Institutional structure.
 - The Governing body is assisted by the IQAC, Dean & College Development Council in achieving the Institution's vision & mission objective with a participatory, decentralized & democratic structure of management & leadership.
 - On the third strata of governance is the Principal assisted by **the Academics Council, Internal Administrative Committee, Internal Finance & Audit Committee & Other Regulatory Bodies** with the Institute to oversee the day to day functioning of the Institute – the policy building & implementation is then carried out by the next governing level comprising of Student Representative Bodies mentored by the faculty advisors – the faculty representative being an irreplaceable part of each strata of governance.
 - This entire structure is supported by ancillary stakeholders such as **Alumni, Parents-Teacher, Local Authorities, Affiliating Bodies.**
- The Institution has a *phenomenal infrastructure, unique teaching pedagogy and skillful practices* to foster the incipient needs of legal education, which is duly governed by eminent Academicians, Administrators, Affiliating University and Local Authorities, since its inception.

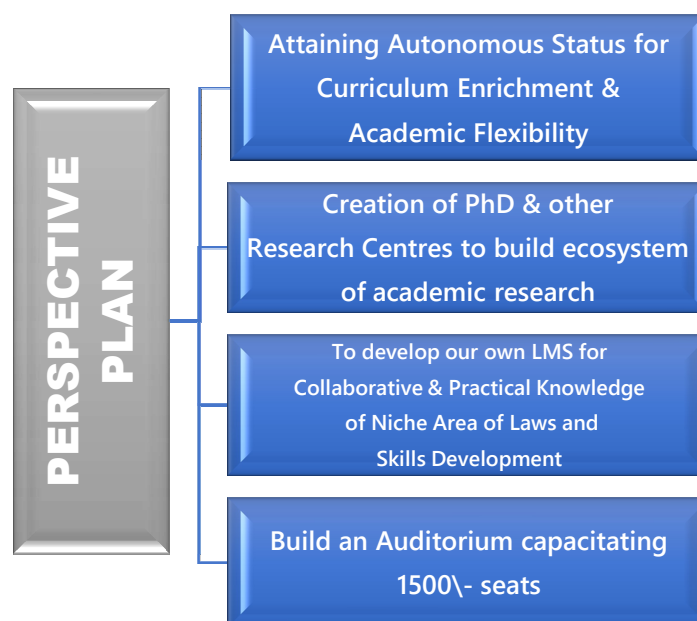
NATURE OF GOVERNANCE

The Institute strategizes and build policies in pursuance of its vision and mission. The Institute has built a legacy of competent & quality professionals in the course of **demonstrative and practical learnings** with effective career building and skill developing efforts.

- The Institute follows the guidelines from its **Statutory Governing Body** (BCI, AISHE and Devi Ahilya Vishwavidhyalay) and aims for continuous improvement by implementation of ISO 9001:2015 for Quality Management System and ISO 14001:2015 for Effective Environmental Management System. In order to participating in attaining the accreditation from NAAC& NIRF.
- Participation is ensured from DAVV University, Teaching and Non-Teaching Staff members, Members of Society (Icon Education Society), Resource Persons & Experts from Industry and Administration along with the Dean of the Institution.
- **The decision-making process is Transparent and Democratic.** All the decisions are made in two levels – the collective policy implementation decision relating to academic, administrative & financial are undertaken by the governing body, IQAC, College Development Council & the Dean while the day-to-day monitoring & decisions are handled by the Principal in consultation with various bodies, students & faculty consultation in staff meetings.

- The Institution adheres to a strong and effective **Administrative Body** which manages administrative work related to infrastructure and Campus maintenance by Internal Administrative Committee headed by Executive Director, Administration.
- The Institute maintains **financial autonomy in decision making** at each level. The major budgetary decisions relating to infrastructural and investment requirements are done by the Governing Body while the IQAC is vested with autonomy for budget allocation relating to day-to-day functions.
- The Institution is **IT enabled and office automation** has been introduced in admission, student information, student evaluation and finance with a dedicated IT Cell.
- The IQAC accesses and forwards requirements related to **manpower, infrastructure and finance** to the Governing Body for approval which is then executed by the **HR Department**.
- The Institution has created an eco-system of Research and Innovation and has created an **Institutional Innovative Council** for promotion of Alternative Dispute Resolution, Entrepreneurship and Research activities.
- For promoting and honing research skills, Research and Publication Cell is established and numerous activities are conducted and **Student and Faculty coordinators are acknowledged and awarded** for their contributions.
