Nearly 7.5% of the Indian population suffers from some form of mental disorder. India accounts for 15% of the global mental, neurological and substance abuse disorder burden. Moreover, persons with mental disorders are also known to be associated with a wide range of social and societal problems, if their illness is unrecognized or is inappropriately managed. An even more troubling fact is that there is an extreme shortage of mental health workers like psychologists, psychiatrists, and trained nurses in India. For example, there are only 3 psychiatrists per million people in India, while the corresponding figures for the USA and China are 105 and 22 psychiatrists, respectively. A huge majority of mental health professionals are located in urban areas. Hence, the shortage of trained mental health specialists in rural India is more severe.

The experience during the pandemic has also reinforced the need to focus on digital technologies, capacity building of frontline health professionals, as well as researchers and clinicians, and to focus on the health needs of marginalized populations. Resilient health systems which are focused on comprehensive health care provision along the life cycle should be a priority. Working across the life spectrum from perinatal mental health, to

child/school mental health, youth mental health, adult mental health, geriatric mental health, and highlighting attention towards public health priorities should be an area of focus.

Research, advocacy, development of policy recommendations, and supportive legal frameworks and advancements can play a crucial enabler role in enabling the country and states to better respond to priority health needs.



5. NLIU will establish a mechanism for resource sharing of the reading/training materials at library and online with IIL.
6. NLIU will engage with mental health experts and collaborators at IIL for designing courses or delivering lectures to the students on selected and specialized topics.
7. NLIU with IIL will explore the opportunities for collaborating with other stakeholders and individuals working in the domain of law, policy and mental health after mutual understanding.

D. EXCHANGE OF HUMAN RESOURCES

The Parties agree to explore ways of encouraging collaboration between researchers/faculty members from the two institutions. Specifically, the two institutions would identify appropriate researchers/faculty members as key collaborators, Principal Investigator(s)/ Co-Investigator(s) at their respective ends, and encourage members of their researchers/faculty to undertake short visits for lectures, facilitate research projects at either end, etc. The terms and conditions for each visit or an assignment, including those concerning stipend, travel, and housing, would be worked out between the partner institutions. The resource sharing of the reading/training materials at library can also be accessed mutually among the parties.

E. AREAS OF COOPERATION

The Parties agree to explore ways of encouraging collaboration between researchers/faculty members from the two institutions. Specifically, the two institutions would identify appropriate researchers/faculty members as key collaborators, Principal Investigator(s)/ Co-Investigator(s) at their respective ends, and encourage members of their researchers/faculty to undertake short visits for lectures, facilitate research projects at either end, etc. The terms and conditions for each visit or an assignment, including those concerning stipend, travel, and housing, would be worked out between the partner institutions. The resource sharing of the reading/training materials at library can also be accessed mutually among the parties.



B. SCOPE OF AGREEMENT

This Memorandum of Understanding (MoU) provides for an overarching framework for collaboration for research and academic activities between both the parties that can be conducted during the period of the MoU.

The scope of activities shall include, but not be limited to, partnering for research and implementation projects focusing on the intersection of law, rights, marginalization and mental health; providing technical support to programs like developing courses on mental health law or related capacity building initiatives; facilitating internship programmes for students interested in mental health law and rights; queer and disability rights; criminal justice and psychology and organizing knowledge sessions like seminars, workshops, talks on mental health and law, as well as courses etc.

C. TERMS AND CONDITIONS OF COOPERATION

For fulfilling the objectives of this agreement, following are the roles and responsibilities of each party:

1. Second Party will support and provide key technical support to First Party in law and mental health programs after mutual understanding. IIL will also seek technical support and guidance from key faculty, staff members and students from NLIU to refine its programs and projects focussing on law, rights, marginalization, policy and mental health.
2. IIL will establish a collaboration with nominated individuals from NLIU to partner in the research programmes and initiatives as Co-investigators and/or collaborators.
3. IIL will jointly identify and pursue opportunities with NLIU for formulation and submission of new research and implementation project proposals for possible funding by government and external agencies as per the mutual understanding.
4. IIL will establish a mechanism to engage the students of NLIU under apprentices/internships/research associates in various projects and activities arising from time to time as per the policies.



This MoU expresses a mutual desire by the NLIU, Bhopal and IIL, to cooperate in collaborative research, academics and implementation in law, rights, marginalization, policy and public health (especially mental health). Additional areas of cooperation may be added with the written consent of both the parties. Both parties shall act in good faith to ensure that the objectives in this Memorandum are realized.

F. TERMS OF AGREEMENT

1. Progress in realizing the terms and conditions referred to herein will be reviewed periodically as mutually agreed. The Memorandum may be amended at any time by mutual consent in writing by both parties.
2. Both parties reserve the right to terminate this Memorandum by tendering three months written notice to the other party.
3. The implementation and/or continuance of programmes or projects established pursuant to this Memorandum prior to the effective date of termination shall not be affected by the termination of this Memorandum.

G. Financial

There would be no financial commitment on either side as a part of this MOU. However, task specific financial arrangement as per internal policies of both the parties could be considered as per the mutual understanding.

H. INTELLECTUAL PROPERTY AND CONFIDENTIALITY

1. IIL and NLIU agree to respect each other's rights to Intellectual Property (IP). All background IP used in connection with this MoU shall remain the property of the Party that introduces it. No license is granted to any Party to use another Party's Background IP, unless specifically agreed to. Further, the IP rights that arise as a result of any collaborative research or joint activity under this MoU would be subject



K. TERMINATION

1. This Memorandum shall come into force immediately upon the signature by parties.
2. The validity of this Memorandum is initially for five years from the date of its execution, and the same can be further extended by mutual agreement, if required.
3. This Memorandum can be terminated by either party by giving advance notice of three months without jeopardizing any work or collaboration between both the parties.

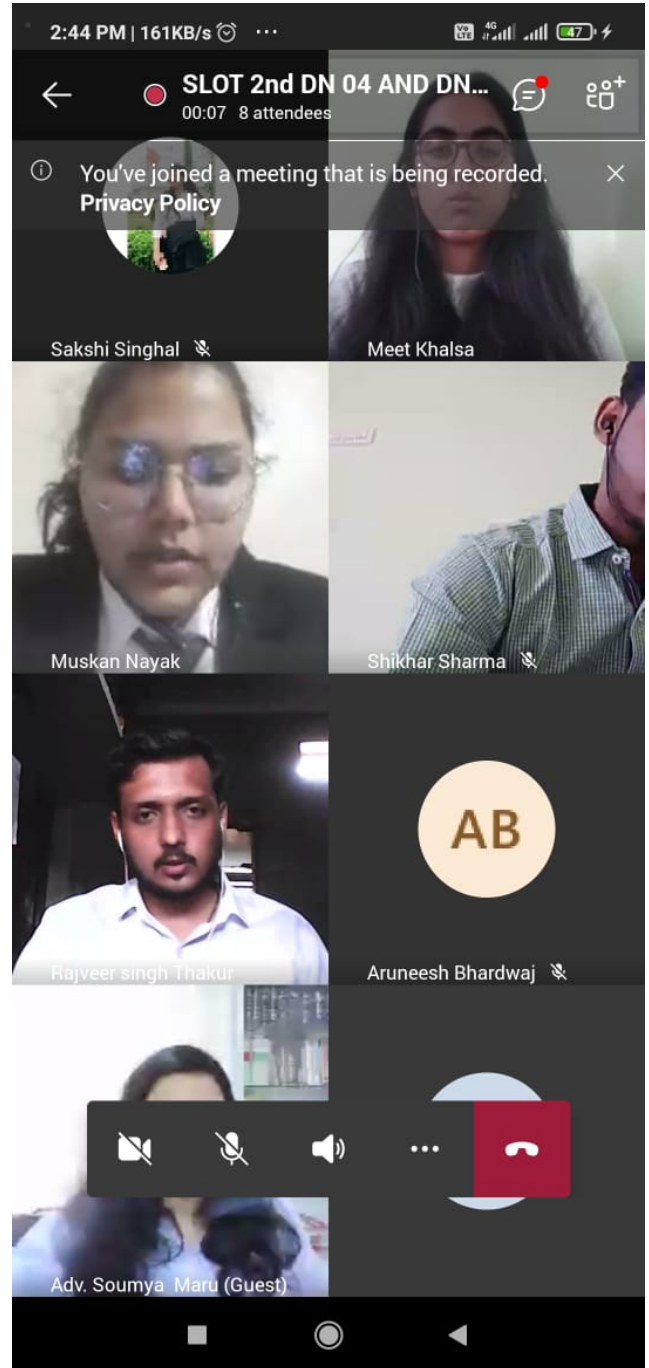
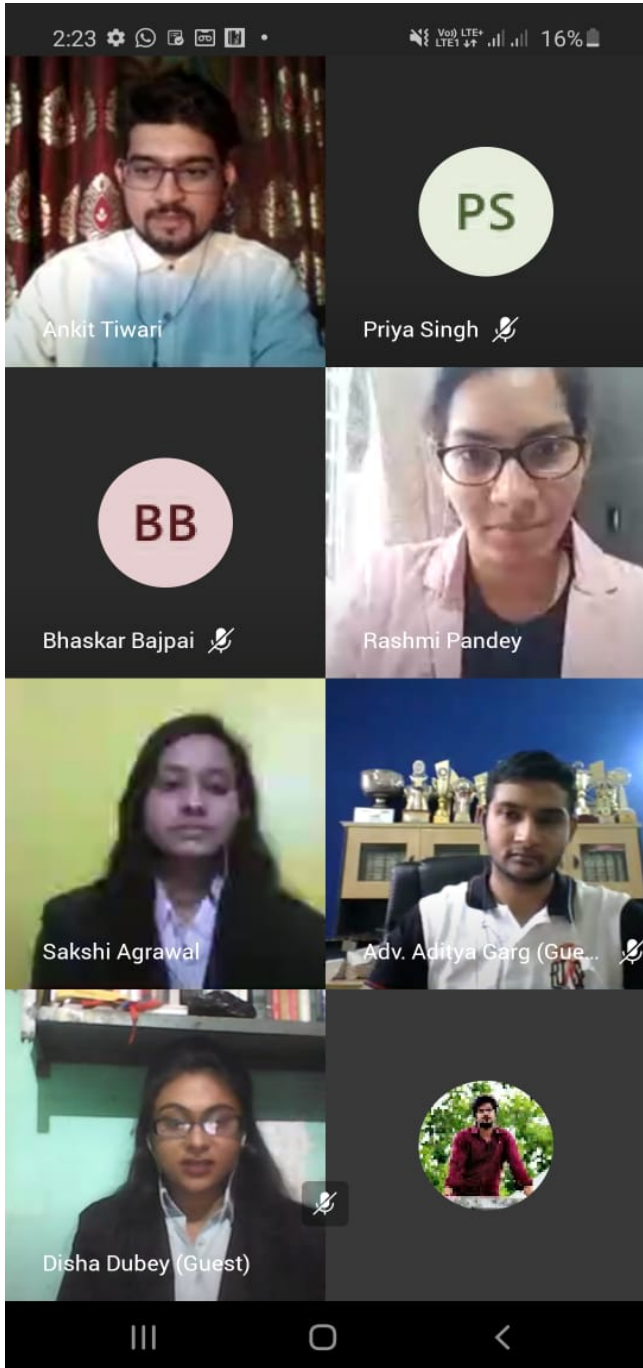
“Webinar on Interdisciplinary Approach between Law and Management”

And Whereas the PMU, e-Nyayaganga, NLIU, Bhopal desires to collaborate and work closely with the **Legal Aid Clinic, Indore Institute of Law, Indore** and seeks to promote the Institution-to-Institution partnerships through this Memorandum of Understanding to work towards digital legal literacy awareness programme and development of Model Legal Aid Clinics.



SCOPE OF AGREEMENT

This Memorandum of Understanding is signed between the NLIU, Bhopal, as First Party and Indore Institute of Law, Indore as Second Party for collaboration that shall encompass exchange of faculty coordinator, the PMU members (e-Nyayaganga) and representatives of Legal Aid Clinic between the two parties. In addition, active efforts shall be taken to strengthen access to justice advocacy and develop and disseminate need-based content for digital legal literacy in a collaborative spirit.

I. TERMS AND CONDITIONS OF COOPERATION

1. The NLIU, Bhopal and Indore Institute of Law, Indore shall collaborate to create and disseminate digital legal literacy content, including reading material and training modules, wherever feasible. Such collaboration will be based on mutually agreeable terms and conditions expressly agreed between the parties;
2. Faculty Coordinator and Representatives from Legal Aid Clinic, Indore Institute of Law, Indore shall be invited for workshops, symposiums and round-tables organised by PMU, e-Nyayaganga. The financial implications shall be mutually worked upon;
3. The modalities for exchange of reading material and training modules for dissemination under the e-Nyayaganga project shall be laid down through mutual discussion;
4. Faculty Coordinator and Representatives of Legal Aid Clinic, Indore Institute of Law, Indore are welcome to organize digital legal literacy programmes under the banner of e-Nyayaganga in collaboration with the PMU, e-Nyayaganga, NLIU, Bhopal;
5. PMU, e-Nyayaganga, NLIU, Bhopal and Legal Aid Clinic Indore Institute of Law, Indore shall explore the possibility of taking up collaborative steps for executing e-Nyayaganga Project, and financial implications shall be mutually worked upon;



6. Any financial implication emerging from the collaborations shall be worked out, and decisions shall be taken with mutual agreement between the two parties.

II. AREAS OF COOPERATION

This Memorandum expresses a mutual desire by the PMU, e-Nyayaganga, NLIU, Bhopal and Legal Aid Clinic, Indore Institute of Law, Indore to cooperate in creating digital legal literacy content for pan-India digital legal literacy programme under e-Nyayaganga and develop an architecture for Model Legal Aid Clinic. Additional areas of cooperation may be added with the written consent of both the Parties. Both parties shall act in good faith to ensure that the objectives in this Memorandum are realized.

III. TERMS OF AGREEMENT

1. Progress in realizing the terms and conditions referred to herein will be reviewed periodically as mutually agreed. The Memorandum may be amended at any time by mutual consent in writing by both parties.
2. The Department of Justice, Ministry of Law and Justice, Government of India will supersede this Memorandum at any stage.
3. Both parties also reserve the right to terminate this Memorandum by giving three months written notice to the other party.
4. The implementation and/or continuance of programmes or projects established pursuant to this Memorandum prior to the effective date of termination shall not be affected by the termination of this Memorandum.

IV. INTELLECTUAL PROPERTY AND CONFIDENTIALITY

1. In respect of activities and programmes organised under the banner of the e-Nyayaganga project, the intellectual property and commercial exploitation of the same (including without



limitation, trademarks and service marks, copyrights, patents, designs and confidential information pertaining thereto) shall rest with the Department of Justice, Ministry of Law and Justice, Government of India.

2. Neither party shall, at any time, disclose to any third party any confidential information of the other party which is acquired in the course of activities under this Memorandum, without the prior consent of the other party in writing.

V. NON-BINDING NATURE OF MEMORANDUM

Nothing in this Memorandum shall be construed as creating any contract, agency or other legal relationship between the parties. This Memorandum is only a non-binding statement of intent to foster genuine and mutually beneficial collaboration to design and develop digital legal literacy content and spread legal awareness through the digital medium.

VI. RESOLUTION OF DISPUTE

Any issues that are not addressed or stipulated in this MoU shall be discussed and resolved through negotiation in good faith, and such resolution shall be incorporated as written amendments to this MoU by mutual agreement between the Parties.

No disputes are foreseen in the implementation of the MoU. However, both the Parties agree that if any dispute arises between them, efforts will be made to settle the same as amicably as possible. If the dispute remains unsettled, it will be referred for resolution bilaterally to the Vice Chancellor, National Law Institute University, Bhopal and the Director & Dean-Academics, Indore Institute of Law, Indore. The decisions so arrived at shall be final and binding on the parties to this MoU.

VII. TERMINATION



1. This Memorandum shall come into force immediately upon the signature of the parties.

PREAMBLE

ARTICLE 9: LEGAL EFFECT







5. Dispute Resolution:







5.2 The academic programs include, but not limited to, seminars, webinars, workshops, mentorship programs, conferences, research projects and other activities.

ARTICLE 6: INTELLECTUAL PROPERTY CONSIDERATIONS

6.1 Any intellectual property that arises from work undertaken under this MoU shall be owned by the party or parties responsible for its creation.

6.2 Neither party shall use the institutional name and logo of the other party without prior written communication.

ARTICLE 7: FINANCE

The financial arrangements for facilitating the MoU will be mutually agreed separately depending on the nature of the assignments.

ARTICLE 8: LIABILITY

Except for the loss and damages caused through gross negligence or intent, neither of the Parties shall have any liability to each other under this MoU.

ARTICLE 9: LEGAL RELATIONSHIP

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this MoU shall create any legal or financial obligation between them.

ARTICLE 10: GENERAL COORDINATORS

At Indore Institute of Law, and at Memo Pundits, the responsibility for the coordination of the collaboration will be on the persons named by Indore Institute of Law, and Memo Pundits, respectively.


ARTICLE 11: COMMENCEMENT, RENEWAL AND TERMINATION OF MOU

11.1 This MoU shall become effective on the date of signing by both the parties and shall remain valid thereafter for a period of three years from the date of signing by the representatives of each institution who is authorized to sign on behalf of that institution.


11.2 After expiration of the period, the MoU may be renewed by mutual agreement between the parties for a future period.

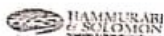



MEMORANDUM OF UNDERSTANDING ON KNOWLEDGE EXCHANGE/ EXCHANGE

This Memorandum of Understanding (MoU) is effective as of 1/04/20 (Effective Date) to establish an affiliation by and between Indore Institute of Law, Indore a law college established in the year 2020, affiliated with DAVV and recognized by Bar Council of India; hereinafter referred to as IIL.

And

Society of Construction Law, New Delhi formed with an affiliation to the Society of Construction Law, London, UK in 1983; hereinafter referred to as SCL

PREAMBLE

WHEREAS, IIL and SCL have many areas of common interest in Law, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research. NOW THEREFORE, IIL and SCL have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

ARTICLE 1: OBJECT

Both the Institution agree to develop and facilitate collaborative activities in the academic areas of mutual interest, on a reciprocation bases. The Institutions shall seek to promote –

1. The exchange of resource persons/faculties to the mutual benefit of the associating institutions
2. Collaborations in the field of teaching, research & development and consultancy in the field of mutual interest
3. The exchange of academic materials and publications,
4. Conducting lectures,
5. Undertaking joint research,
6. Attachment of staff for purposes of curriculum development and research skills,
7. Participating in seminars, symposiums, and other types of academic activities,
8. Co-supervising post-graduate students,
9. Conducting study tours and joint consultancy work.

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including those concerning salary, travel funding, health insurance, and housing will be worked out between the institutes. A separate agreement will be entered into giving such details including term of exchange of any intellectual property.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of IIL, and a programme coordinator from the side of SCL, will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: CONFIDENTIAL INFORMATION

Both the Institution does not absolve any confidential information during the research activity.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both institutes to this Memorandum. Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same. Before any registration or commercialisation of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes, such consent not to be unreasonably withheld.

ARTICLE 5: VALIDITY

The Memorandum shall remain in force for a period of FIVE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review

ARTICLE 6: TERMINATION

Either institution may terminate the MoU by giving written notice of six months in advance to the other institution.

ARTICLE 7: AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

ARTICLE 8: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions.

ARTICLE 9: LEGAL EFFECT



MEMORANDUM OF UNDERSTANDING

CONSIDERING that INDORE INSTITUTE OF LAW (IIL) is a private academic institution in INDIA that has a mandate to conduct Research, Teaching and provide Community Service. The university's Training and community service priority areas is the democracy, peace and the promotion of human rights and freedoms in India. Conducting research and training of young people is among its objectives and principles for promoting human rights in India. IIL is the national academic institution responsible for the implementation of a national human rights education strategy, which also includes actions of educating, training and research in collaboration with different national and international actors.

CONSIDERING that United for Human Rights (UHR) a.k.a Youth for Human Rights International (YHRI), a California (USA) public benefit (not for profit) corporation dedicated solely to educational and related humanitarian purposes and a full tax-exempt organization under the Internal Revenue Code of the United States, is committed to promoting the instruction of people worldwide on their human rights and accompanying responsibilities through the United Nations Universal Declaration of Human Rights; assisting and enabling young persons to become leaders, advocating for tolerance, peace and sustainable development;

COGNIZANT of the existing relationship between the IIL and UHR;

DESIROUS of further improving and strengthening the existing relationship between the IIL and UHR by establishing appropriate working arrangements for the satisfactory implementation of the Memorandum of Understanding;

CONVINCED that closer cooperation and collaboration between the Parties to this memorandum of understanding would further their mutual interest.

HAVE AGREED AS FOLLOWS:

ARTICLE I
OBJECTIVES

This memorandum aims at founding an appropriate framework which enables the Parties to facilitate and coordinate cooperation between them in the areas of mutual interest and particularly in the area of developing human rights education, training and research programs in India.

ARTICLE II
AREAS OF COOPERATION

In order to achieve the objectives defined in Article 1, the Parties shall develop close cooperation on the basis of regular consultations in the fields of common interest and in conformity with the terms

of this MOU as well as the dispositions and modalities of the Constitutive Instruments for the Parties. For this purpose, the Parties shall:

1. Facilitate and support their mutual participation in IIL's implementation of human rights-based education, training and research programs for universities and schools using UHR and YHRI materials;
2. Facilitate and support their mutual participation in IIL's implementation of human rights-based education, training and research programs for military, police and other security forces and law enforcement agencies using UHR and YHRI materials;
3. Facilitate and support their mutual participation in IIL's implementation of human rights-based education, training and research programs for governmental entities and people working in administrative offices or any other post of the different government hierarchies: local, regional and federal government administrative offices.
4. Play a partnership role in the development, implementation and promotion of human rights broadly in Central India;
5. Monitor, evaluate, and advise on the implementation and results of such research, educational and awareness programs in the best interest of India citizens.

ARTICLE III
MEETINGS AND RECIPROCAL REPRESENTATION

When appropriate, the Parties shall undertake to invite each other to attend meetings of mutual interest and other activities of their respective organizations.

ARTICLE IV
FINANCING

1. Financial obligations incurred by the Parties as a result of this Memorandum of Understanding or the exchange of letters issued on the basis of the Memorandum of Understanding shall be subject to the decisions taken by their governing bodies as to the availability of funds and to their budgetary and financial regulations. No financial commitment shall be valid and enforceable against the party to be charged unless signed by one or more of its officers or directors.

2. This Memorandum of Understanding does not represent any commitment with regard to funding on the part of either Party.

ARTICLE V
PRIVILEGES AND IMMUNITIES

Each Party shall grant the other such privilege and immunities as are applicable under Agreements on the matter and according to general principles of International law.

ARTICLE VI
SETTLEMENTS OF DISPUTES

Any dispute that may arise over the interpretation of application of this Memorandum of Understanding shall be settled by direct negotiations between the Parties.

ARTICLE VII
AMENDMENTS

1. The Parties may set additional arrangements which are in conformity with this memorandum and its objectives.
2. The articles of the Memorandum of Understanding shall be subject to review or amendments at any time and upon the request in writing of either Party.
3. Any instrument containing amendment shall be appended to and become an integral part of the Memorandum of Understanding
4. Any review and/or amendment of this Memorandum of Understanding should have the consent of both Parties.

ARTICLE VIII
TERMINATION

This memorandum of U. shall be in force for 5 years from the date of commencement
Each party has the right to terminate this agreement by giving advance written notice to the other party. The Memorandum of Understanding shall terminate thirty (30) days after the date of such notice.


