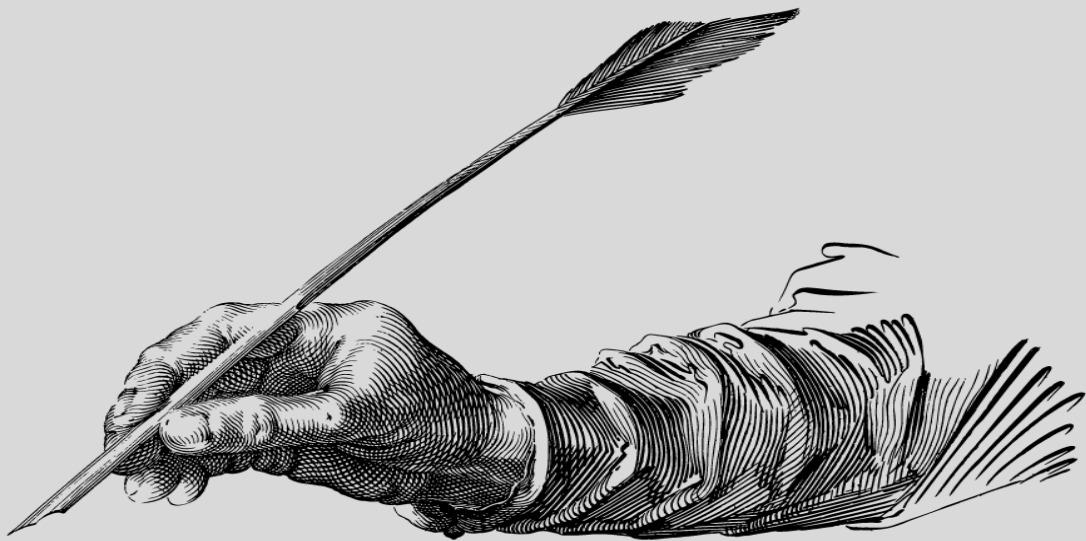

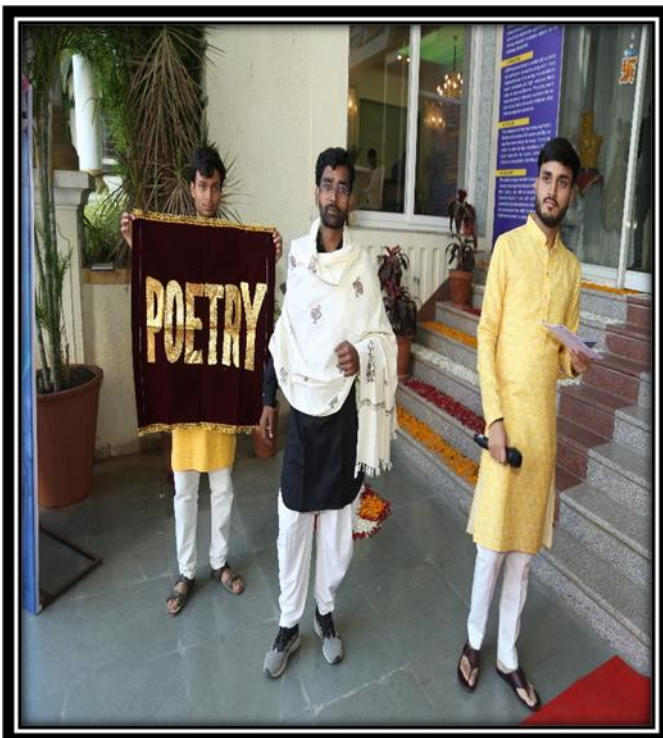
## “POETRY COMPETITION”

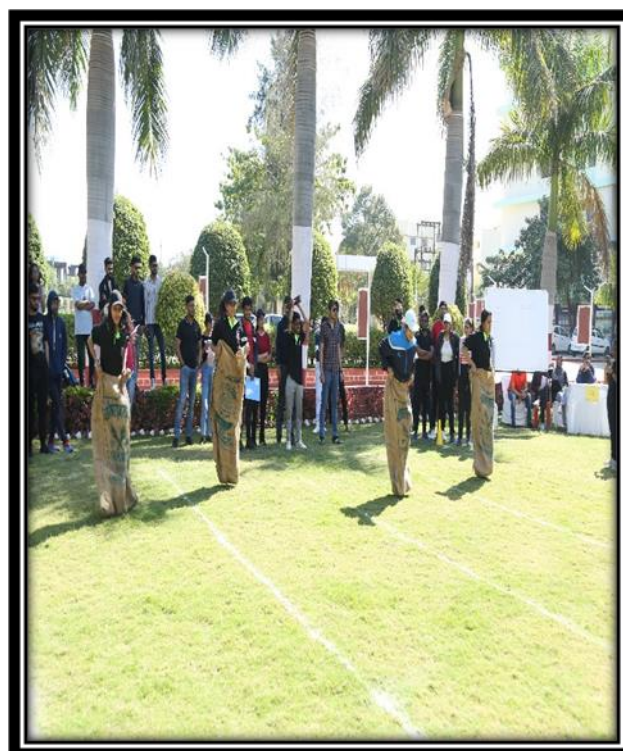
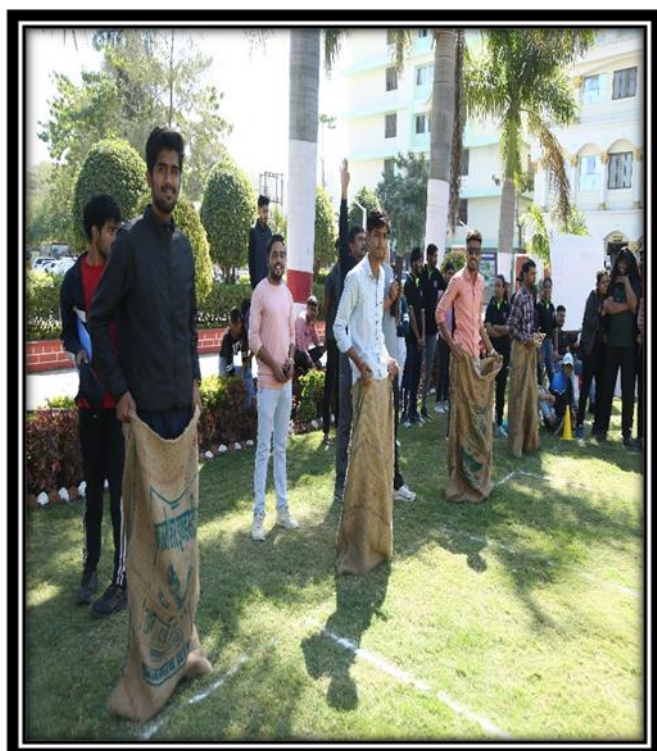
## “SACK RACE COMPETITION”

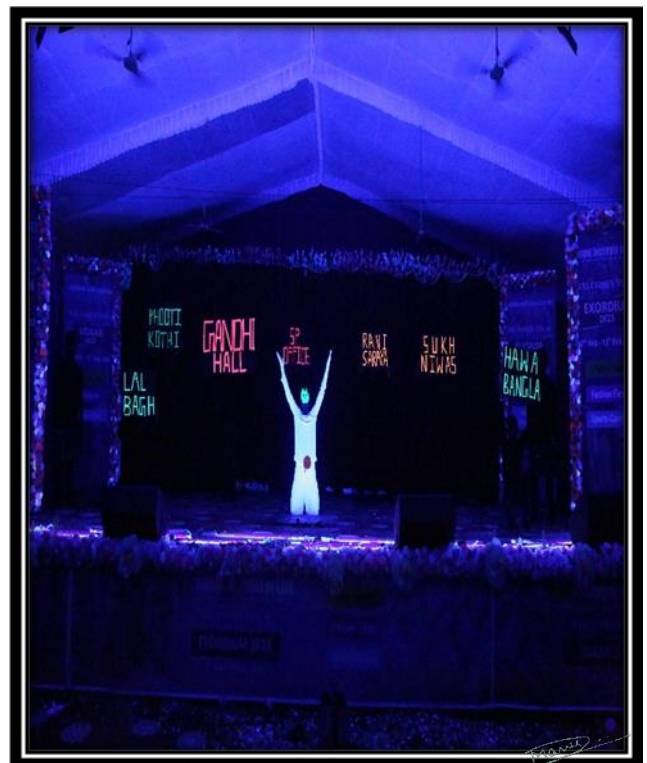
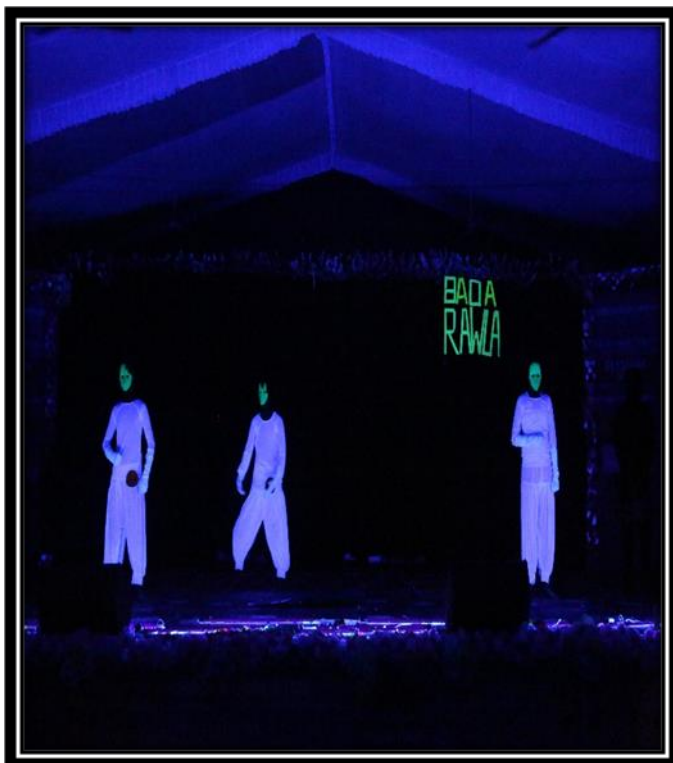
## UV Act Competition

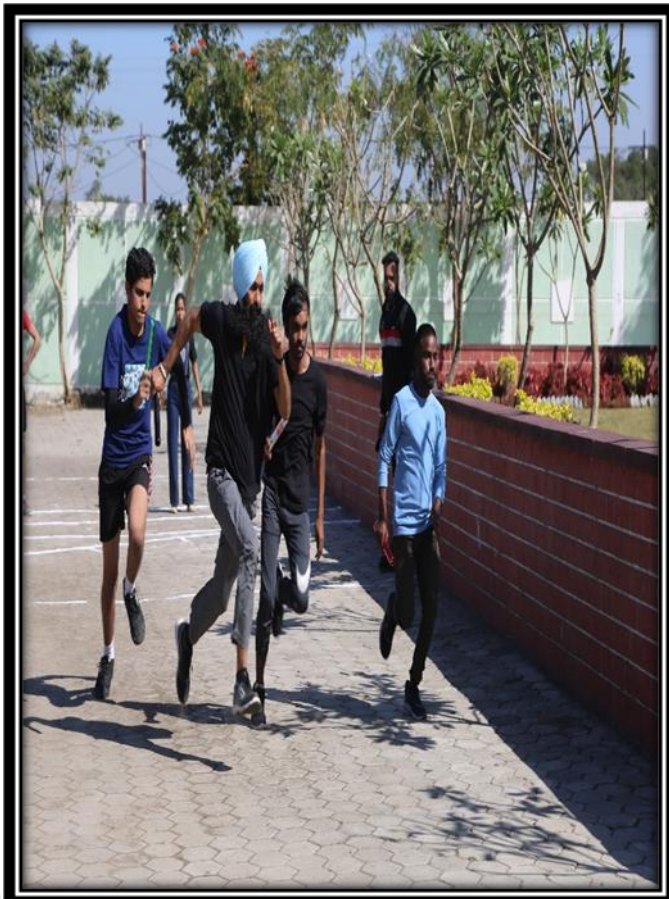
## “RELAY RACE COMPETITION”

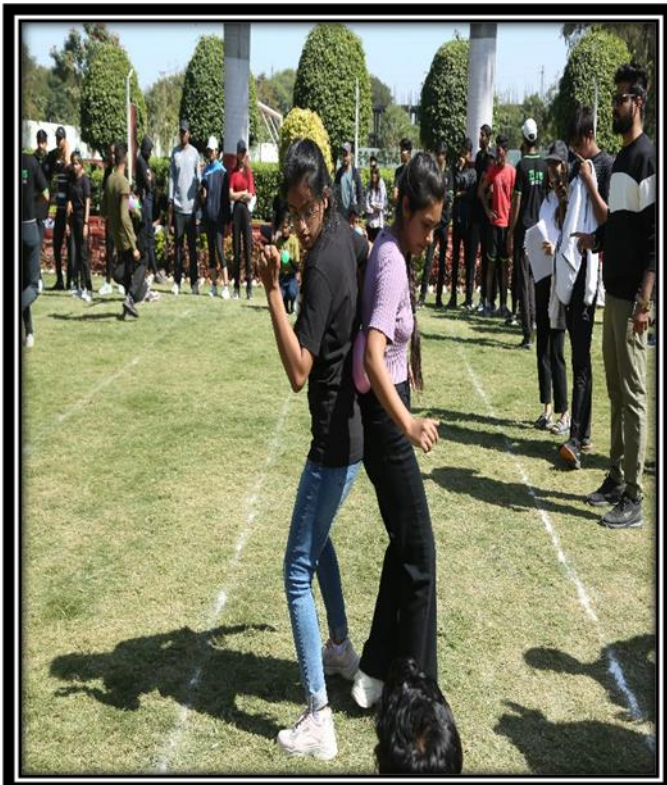
## One Minute Games

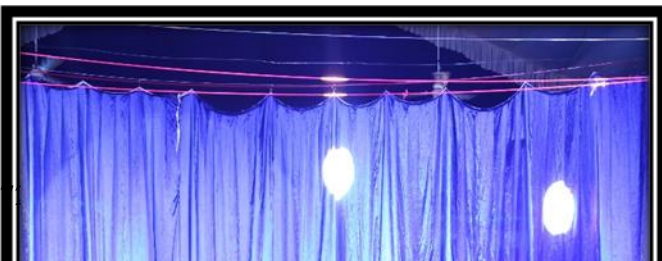
## Group Song Competition
